# **Transaction Summary**

The transaction closed on Mar 28 2018 and matures in Mar 2030. The pool's current aggregate principal balance is \$832.1 million compared to \$840.0 million at close.

The largest loan of the pool (7.8%) is secured by Aspen Lake Office Portfolio located in metropolitan area. Occupancy at the subject was 88%. The major tenants included OFFICE (23.38%) and Q2 SOFTWARE (17.58%). The second largest loan of the pool (7.2%) is secured by AFIN Portfolio located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Kohl's Department Store (8.88%) and Best Buy (6.42%). The third largest loan of the pool (5.8%) is secured by Midwest Hotel Portfolio located in metropolitan area. Occupancy at the subject was 69%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.90% and 32 months as of 10/15/2020, respectively. There are a total of 43 loans and 112 properties in the portfolio. The appraisal LTV was approximately 58.3% compared to the Original loan to value (LTV), which was approximately 58.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.84x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.






#### Local Distribution





Most recent net operating income debt yield ranged from -2% to 23% with a weighted average NOI debt yield of 9.9%. NOI debt yield ranged from -2% to 23%. There were 1 assets (1% of total balance) with NOI debt yield between -2% and 0%, 1 assets (2% of total balance) with NOI debt yield between 0% and 2%, 8 assets (19% of total balance) with NOI debt yield between 6% and 8%, 12 assets (31% of total balance) with NOI debt yield between 8% and 10%, 10 assets (32% of total balance) with NOI debt yield between 10% and 12%, 6 assets (10% of total balance) with NOI debt yield between 12% and 14%, 4 assets (5% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24%

There were 1 assets (0.6% of total balance) with NCF DSCR between -0.5x and 0.0x, 2 assets (4.1% of total balance) with NCF DSCR between 0.0x and 0.5x, 17 assets (32.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (30.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (24.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (3.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (1.3% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (3.0% of total balance) with NCF DSCR between 6.0x and 6.5x. 



# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
