Transaction Summary

The transaction closed on Mar 28 2018 and matures in Mar 2030. The pool's current aggregate principal balance is \$831.5 million compared to \$840.0 million at close.

The largest loan of the pool (7.8%) is secured by Aspen Lake Office Portfolio located in metropolitan area. Occupancy at the subject was 88%. The major tenants included LDR Spine USA Inc. (23.38%) and Q2 SOFTWARE (17.58%). The second largest loan of the pool (7.2%) is secured by AFIN Portfolio located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Kohl's Department Store (8.88%) and Best Buy (6.42%). The third largest loan of the pool (5.8%) is secured by Midwest Hotel Portfolio located in metropolitan area. Occupancy at the subject was 69%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.90% and 34 months as of 12/15/2020, respectively. There are a total of 43 loans and 112 properties in the portfolio. The appraisal LTV was approximately 58.2% compared to the Original loan to value (LTV), which was approximately 58.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

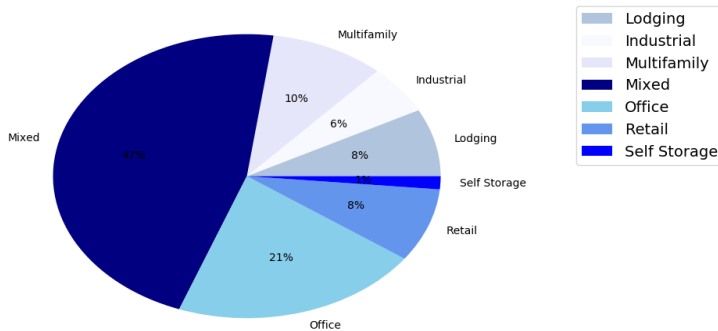

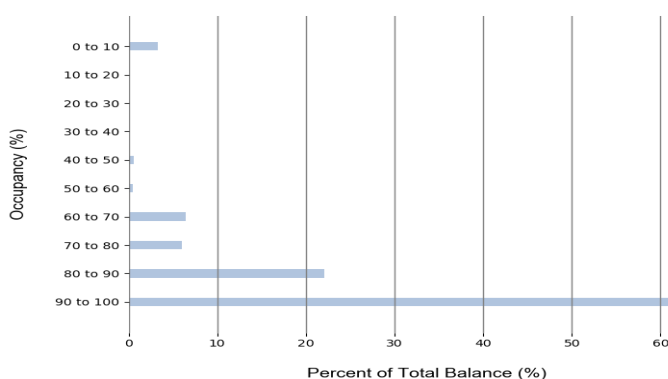

Occupancy Distribution (%)

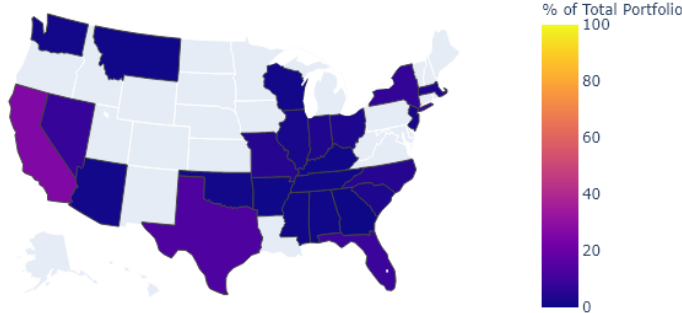

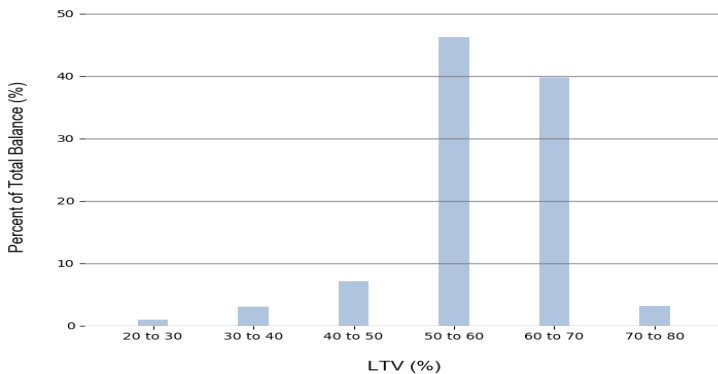
Local Distribution



Among assets in the portfolio, there are 36 properties (26% of total balance) located in California, 11 properties (13% of total balance) in Texas, 8 properties (9% of total balance) in Florida, 5 properties (8% of total balance) in Nevada, 4 properties (7% of total balance) in New York, 5 properties (5% of total balance) in Missouri and 5 properties (5% of total balance) in North Carolina. Other properties are located in the state of Massachusetts, South Carolina, Ohio, Illinois, New Jersey, Arizona, Washington, Oklahoma, Wisconsin, Kentucky, Tennessee, Alabama, Montana, Mississippi, Arkansas and Georgia.

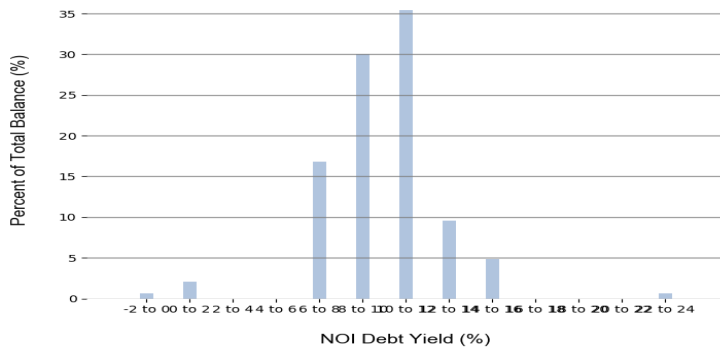

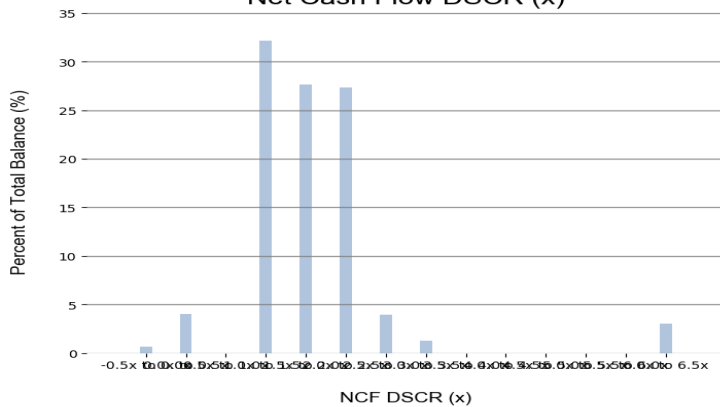
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

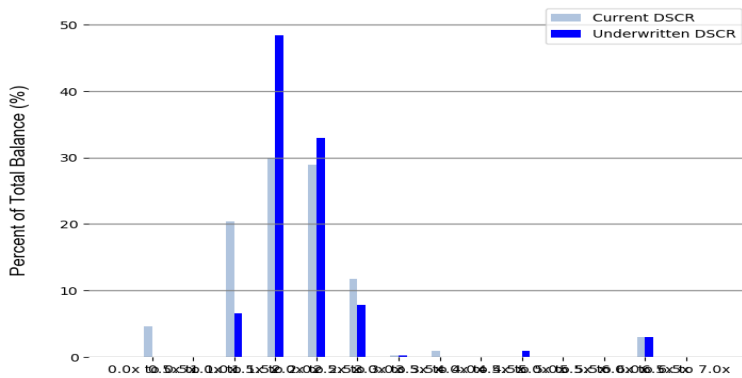

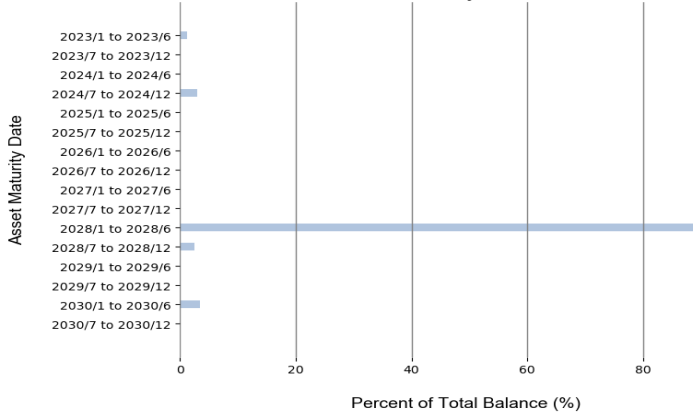
DSCR Distribution (x)

There are 3 assets (4.7% of total balance) with DSCR between 0.0x and 0.5x, 10 assets (20.4% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (30.0% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (28.9% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (11.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.0% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.0% of total balance) with DSCR between 6.0x and 6.5x. There are 1 assets (1.3% of total balance) that have maturity dates between 2023/1 and 2023/6, 1 assets (3.0% of total balance) that have maturity dates between 2024/7 and 2024/12, 39 assets (89.6% of total balance) that have maturity dates between 2028/1 and 2028/6, 1 assets (2.5% of total balance) that have maturity dates between 2028/7 and 2028/12 and 1 assets (3.5% of total balance) that have maturity dates between 2030/1 and 2030/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
