## **Transaction Summary**

The transaction closed on Mar 28 2018 and matures in Mar 2030. The pool's current aggregate principal balance is \$825.5 million compared to \$840.0 million at close.

The largest loan of the pool (7.9%) is secured by Aspen Lake Office Portfolio located in metropolitan area. Occupancy at the subject was 88%. The major tenants included LDR Spine USA Inc. (46.76%) and LDR Spine USA Inc. (23.38%). The second largest loan of the pool (7.3%) is secured by AFIN Portfolio located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Kohl's Department Store (6.99%) and Best Buy (6.42%). The third largest loan of the pool (5.7%) is secured by Midwest Hotel Portfolio located in metropolitan area. Occupancy at the subject was 69%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.89% and 50 months as of 04/15/2022, respectively. There are a total of 43 loans and 107 properties in the portfolio. The appraisal LTV was approximately 62.3% compared to the Original loan to value (LTV), which was approximately 59.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.76x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





# Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from -6% to 33% with a weighted average NOI debt yield of 10.6%. NOI debt yield ranged from -6% to 33%. There were 1 assets (2% of total balance) with NOI debt yield between -6% and -4%, 1 assets (2% of total balance) with NOI debt yield between -2% and 0%, 1 assets (2% of total balance) with NOI debt yield between 0% and 2%, 4 assets (12% of total balance) with NOI debt yield between 6% and 8%, 14 assets (26% of total balance) with NOI debt yield between 8% and 10%, 8 assets (28% of total balance) with NOI debt yield between 10% and 12%, 7 assets (16% of total balance) with NOI debt yield between 12% and 14%, 6 assets (8% of total balance) with NOI debt yield between 14% and 16% and 1 assets (4% of total balance) with NOI debt yield between 32% and 34%.

There were 1 assets (2.0% of total balance) with NCF DSCR between -1.0x and -0.5x, 2 assets (4.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (1.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 10 assets (22.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 12 assets (20.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (38.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (3.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.0% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (3.6% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (3.0% of total balance) with NCF DSCR between 6.5x and 7.0x. 



There are 1 assets (2.0% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (4.3% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.6% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (14.3% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (23.7% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (28.3% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (18.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.0% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (3.6% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (3.0% of total balance) with DSCR between 6.5x and 7.0x. There are 1 assets (11.0% of total balance) that have maturity dates between 2023/1 and 2023/6, 1 assets (25.0% of total balance) that have maturity dates between 2024/7 and 2024/12, 39 assets (739.4% of total balance) that have maturity dates between 2028/1 and 2028/6, 1 assets (21.0% of total balance) that have maturity dates between 2028/7 and 2028/12 and 1 assets (29.1% of total balance) that have maturity dates between 2030/1 and 2030/6.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
