## **Transaction Summary**

The transaction closed on Jul 10 2018 and matures in Jul 2028. The pool's current aggregate principal balance is \$782.5 million compared to \$798.0 million at close.

The largest loan of the pool (6.4%) is secured by 20 Times Square - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 9%. The largest tenant was THE HERSHEY COMPANY (43.20%). The second largest loan of the pool (6.2%) is secured by Riverfront Plaza located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Hunton Andrews Kurth (14.08%) and Hunton Andrews Kurth (10.38%). The third largest loan of the pool (5.1%) is secured by Torrance Technology Campus located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 91%. The major tenants included Level 3 Communications (80.11%) and TORRANCE MEMORIAL MEDICAL CENTER (10.74%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.90% and 31 months as of 12/15/2020, respectively. There are a total of 47 loans and 90 properties in the portfolio. The appraisal LTV was approximately 60.5% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.96x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





#### Occupancy Distribution (%)






#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 17%. There were 2 assets (3% of total balance) with NOI debt yield between 4% and 6%, 5 assets (8% of total balance) with NOI debt yield between 6% and 8%, 9 assets (18% of total balance) with NOI debt yield between 8% and 10%, 18 assets (44% of total balance) with NOI debt yield between 10% and 12%, 3 assets (4% of total balance) with NOI debt yield between 12% and 14%, 6 assets (15% of total balance) with NOI debt yield between 14% and 16% and 4 assets (7% of total balance) with NOI debt yield between 16% and 18%.





## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
