Transaction Summary

The transaction closed on Jul 10 2018 and matures in Jul 2028. The pool's current aggregate principal balance is \$732.6 million compared to \$758.0 million at close.

The largest loan of the pool (6.8%) is secured by 20 Times Square - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 11%. The largest tenant was THE HERSHEY COMPANY (52.53%). The second largest loan of the pool (6.5%) is secured by Riverfront Plaza located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Hunton Andrews Kurth (25.02%) and Branch Banking & Trust Co. (14.83%). The third largest loan of the pool (4.6%) is secured by 5th Street Station located in metropolitan area. Occupancy at the subject was 89%. The major tenants included WEGMANS FOOD MARKETS INC (26.94%) and Dick's Clothing and Sporting Goods (22.21%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.92% and 47 months as of 04/15/2022, respectively. There are a total of 46 loans and 87 properties in the portfolio. The appraisal LTV was approximately 61.2% compared to the Original loan to value (LTV), which was approximately 57.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 77%.





Occupancy Distribution (%)






Local Distribution



There were 1 assets (0.8% of total balance) with NCF DSCR between -0.5x and 0.0x, 3 assets (8.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (5.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (25.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (23.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (8.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (19.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (6.8% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (1.7% of total balance) with NCF DSCR between 6.0x and 6.5x. 



There are 4 assets (9.5% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.6% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (25.5% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (23.4% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (8.3% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (14.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (9.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (6.8% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.7% of total balance) with DSCR between 6.0x and 6.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
