Transaction Summary

The transaction closed on Aug 28 2018 and matures in Aug 2048. The pool's current aggregate principal balance is \$788.4 million compared to \$805.2 million at close.

The largest loan of the pool (6.3%) is secured by Wyvernwood Apartments located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 98%. The second largest loan of the pool (6.0%) is secured by Riverfront Plaza located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Hunton Andrews Kurth (25.02%) and Branch Banking & Trust Co. (14.83%). The third largest loan of the pool (5.6%) is secured by Riverwalk located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 85%. The major tenants included 99 DEGREES CUSTOM INC (11.06%) and PARTNERS COMMUNITY HEALTHCARE (6.12%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.98% and 44 months as of 03/15/2022, respectively. There are a total of 65 loans and 76 properties in the portfolio. The appraisal LTV was approximately 66.0% compared to the Original loan to value (LTV), which was approximately 59.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.67x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.



Type Concentration









There were 1 assets (1.5% of total balance) with NCF DSCR between -1.5x and -1.0x, 6 assets (9.2% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (3.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 17 assets (21.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 20 assets (36.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (12.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (5.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (9.5% of total balance) with NCF DSCR between 3.5x and 4.0x. 



DSCRs ranged from -1.5x to 4.0x.There are 1 assets (1.5% of total balance) with DSCR between -1.5x and -1.0x, 6 assets (9.2% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.9% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (16.7% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (38.3% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (13.9% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (4.4% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (3.6% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (9.5% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.8x.

There are 1 assets (25.0% of total balance) that have maturity dates between 2023/1 and 2023/6, 2 assets (60.8% of total balance) that have maturity dates between 2023/7 and 2023/12, 2 assets (10.7% of total balance) that have maturity dates between 2025/7 and 2025/12, 10 assets (203.0% of total balance) that have maturity dates between 2028/1 and 2028/6, 47 assets (469.3% of total balance) that have maturity dates between 2028/7 and 2028/12, 2 assets (1.9% of total balance) that have maturity dates between 2028/7 and 2028/12, 2 assets (1.9% of total balance) that have maturity dates between 2033/7 and 2033/12 and 1 assets (17.7% of total balance) that have maturity dates between 2048/7 and 2048/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
