Transaction Summary

The transaction closed on Oct 11 2018 and matures in Jun 2032. The pool's current aggregate principal balance is \$654.9 million compared to \$666.0 million at close.

The largest loan of the pool (7.3%) is secured by 1670 Broadway located in metropolitan area. Occupancy at the subject was 88%. The major tenants included TEACHERS - EXISTING OFFICE PREMISES (35.65%) and HUD (12.26%). The second largest loan of the pool (6.9%) is secured by The Buckingham located in metropolitan area. Occupancy at the subject was 62%. The third largest loan of the pool (5.2%) is secured by Lower Makefield Corporate Center - South located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 87%. The major tenants included Crown Cork & Seal USA Inc (20.34%) and Jubilant Pharma Holdings Inc. (7.96%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.99% and 42 months as of 03/15/2022, respectively. There are a total of 50 loans and 65 properties in the portfolio. The appraisal LTV was approximately 59.4% compared to the Original loan to value (LTV), which was approximately 59.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.66x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 17% with a weighted average NOI debt yield of 9.8%. NOI debt yield ranged from 0% to 17%. There were 3 assets (5% of total balance) with NOI debt yield between 0% and 2%, 1 assets (2% of total balance) with NOI debt yield between 2% and 4%, 4 assets (10% of total balance) with NOI debt yield between 4% and 6%, 7 assets (12% of total balance) with NOI debt yield between 6% and 8%, 11 assets (20% of total balance) with NOI debt yield between 8% and 10%, 9 assets (20% of total balance) with NOI debt yield between 10% and 12%, 12 assets (19% of total balance) with NOI debt yield between 12% and 14%, 2 assets (3% of total balance) with NOI debt yield between 14% and 16% and 1 assets (7% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR ranged from 0.0x to 4.0x. There were 5 assets (8.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 7 assets (14.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (20.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 12 assets (22.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (18.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (10.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.3% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (4.3% of total balance) with NCF DSCR between 3.5x and 4.0x. 



There are 3 assets (4.8% of total balance) with DSCR between 0.0x and 0.5x, 7 assets (13.8% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (20.4% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (25.2% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (17.7% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (12.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.3% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
