Transaction Summary

The transaction closed on Dec 12 2018 and matures in Dec 2028. The pool's current aggregate principal balance is \$644.0 million compared to \$651.3 million at close.

The largest loan of the pool (6.9%) is secured by GNL Portfolio located in Dallas-Plano-Irving, TX-33.12% metropolitan area. Occupancy at the subject was 100%. The major tenants included NIBLE STORAGE-SAN JOSE CA (25.41%) and NETSCOUT-ALLENTX (22.35%). The second largest loan of the pool (6.7%) is secured by Heartland Dental Medical Office Portfolio located in Dallas-Plano-Irving, TX-1.85% Washington-Arlington-Alexandria, DC-VA-MD-WV-1.49% Elgin, IL-1.17% Fort Worth-Arlington, TX-0.86% Warren-Troy-Farmington Hills, MI-0.82% Lake County-Kenosha County, IL-WI-0.54% Gary, IN-0.40% Rockingham County-Strafford County, NH-0.17% metropolitan area. Occupancy at the subject was 97%. The major tenants included HD home office (8.80%) and HD PSR Center (4.49%). The third largest loan of the pool (5.8%) is secured by Lafayette Park located in metropolitan area. Occupancy at the subject was 100%. The major tenants included United States Government (5.53%) and DEPT OF LABOR & INDUSTRY (2.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.29% and 26 months as of 12/15/2020, respectively. There are a total of 45 loans and 236 properties in the portfolio. The appraisal LTV was approximately 63.7% compared to the Original loan to value (LTV), which was approximately 59.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.99x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)





Region (by property)



Among assets in the portfolio, there are 46 properties (15% of total balance) located in Florida, 20 properties (10% of total balance) in Texas, 3 properties (6% of total balance) in California, 20 properties (6% of total balance) in South Carolina, 5 properties (6% of total balance) in Minnesota, 3 properties (6% of total balance) in Nebraska, 1 property (5% of total balance) in Massachusetts and 17 properties (5% of total balance) in Georgia. Other properties are located in the state of Colorado, Delaware, New York, Missouri, Maryland, Alabama, Indiana, Alaska, Louisiana, New Hampshire, Michigan, Utah, Illinois, Kansas, Nevada, Pennsylvania, Kentucky, Tennessee, North Carolina, Montana, Iowa, Oklahoma, Ohio, Arizona, Wisconsin, Virginia, Arkansas and New Mexico.

Among all the assets in the portfolio, 2 assets (9% of total balance) had LTVs between 30% and 40%, 1 assets (5% of total balance) with LTVs between 40% and 50%, 12 assets (26% of total balance) with LTVs between 50% and 60%, 26 assets (51% of total balance) with LTVs between 60% and 70% and 4 assets (8% of total balance) with LTVs between 70% and 80%.







Most recent net operating income debt yield ranged from 0% to 17% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 0% to 17%. There were 1 assets (2% of total balance) with NOI debt yield between 0% and 2%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 2 assets (3% of total balance) with NOI debt yield between 6% and 8%, 6 assets (9% of total balance) with NOI debt yield between 8% and 10%, 19 assets (50% of total balance) with NOI debt yield between 10% and 12%, 10 assets (24% of total balance) with NOI debt yield between 12% and 14%, 3 assets (4% of total balance) with NOI debt yield between 14% and 16%, 3 assets (7% of total balance) with NOI debt yield between 16% and 18%

There were 1 assets (1.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (1.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (18.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (48.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (19.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (4.7% of total balance) with NCF DSCR between 5.0x and 3.5x and 1 assets (5.8% of total balance) with NCF DSCR between 5.0x and 5.5x. 

Underwritten DSCR



DSCRs ranged from 0.0x to 6.0x.There are 1 assets (1.8% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.1% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (5.6% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (58.9% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (19.7% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (2.6% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (4.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (5.8% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.
