Transaction Summary

The transaction closed on Dec 28 2018 and matures in Oct 2033. The pool's current aggregate principal balance is \$529.9 million compared to \$541.6 million at close.

The largest loan of the pool (9.9%) is secured by Heartland Dental Medical Office Portfolio located in Dallas-Plano-Irving, TX-2.04% Washington-Arlington-Alexandria, DC-VA-MD-WV-1.64% Elgin, IL-1.28% Fort Worth-Arlington, TX-0.95% Warren-Troy-Farmington Hills, MI-0.90% Lake County-Kenosha County, IL-WI-0.60% Gary, IN-0.44% Rockingham County-Strafford County, NH-0.19% metropolitan area. Occupancy at the subject was 97%. The major tenants included HD home office (8.75%) and HD PSR Center (4.46%). The second largest loan of the pool (8.5%) is secured by Saint Louis Galleria located in metropolitan area. Occupancy at the subject was 88%. The major tenants included GALLERIA 6 CINEMAS (4.22%) and H&M (2.78%). The third largest loan of the pool (6.6%) is secured by Staples Strategic Industrial located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was US Retail Inc (53.13%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.22% and 41 months as of 04/15/2022, respectively. There are a total of 36 loans and 249 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.48x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





Occupancy Distribution (%)







Among assets in the portfolio, there are 19 properties (12% of total balance) located in Texas, 3 properties (11% of total balance) in % of Total Portfolio California, 9 properties (9% of total balance) in Missouri, 45 properties (9% of total balance) in Florida, 5 properties (7% of total balance) in Maryland, 18 properties (5% of total balance) in Georgia, 1 property (5% of total balance) in New Jersey and 29 properties (4% of total balance) in Illinois. Other properties are located in the state of Michigan, Washington, Ohio, Alabama, New York, Connecticut, Indiana, Nebraska, Virginia, North Carolina, Delaware, South Carolina, Nevada, Utah, Wisconsin, Tennessee, Iowa, Oklahoma, Louisiana, Minnesota, Kentucky, Arizona, Arkansas, Colorado, New Mexico, Kansas, Pennsylvania and New Hampshire.





Most recent net operating income debt yield ranged from -14% to 25% with a weighted average NOI debt yield of 9.4%. NOI debt yield ranged from -14% to 25%. There were 1 assets (5% of total balance) with NOI debt yield between -14% and -12%, 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 2 assets (5% of total balance) with NOI debt yield between 4% and 6%, 1 assets (1% of total balance) with NOI debt yield between 6% and 8%, 13 assets (36% of total balance) with NOI debt yield between 8% and 10%, 7 assets (16% of total balance) with NOI debt yield between 10% and 12%, 9 assets (32% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 14% and 16% and 1 assets (2% of total balance) with NOI debt yield between 24% and 26%.

NCF DSCR ranged from -2.5x to 3.5x. There were 1 assets (4.5% of total balance) with NCF DSCR between -2.5x and -2.0x, 2 assets (4.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 7 assets (12.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (51.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (13.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (7.5% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (2.0% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.5x.







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
