Transaction Summary

The transaction closed on Oct 15 2019 and matures in Oct 2034. The pool's current aggregate principal balance is \$802.3 million compared to \$807.7 million at close.

The largest loan of the pool (6.3%) is secured by Grand Canal Shoppes - Trust located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Venetian Casino Resort (5.55%) and The Venetian Resort (Showroom / Theater) (5.12%). The second largest loan of the pool (5.0%) is secured by Phoenix Industrial Portfolio II located in metropolitan area. Occupancy at the subject was 100%. The major tenants included DuBois Logistics (25.63%) and Generac Power Systems Inc (24.76%). The third largest loan of the pool (4.9%) is secured by 600 & 620 National Avenue located in metropolitan area. The largest tenant was Google (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.28% and 16 months as of 12/15/2020, respectively. There are a total of 70 loans and 97 properties in the portfolio. The appraisal LTV was approximately 63.8% compared to the Original loan to value (LTV), which was approximately 63.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.37x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.









Among assets in the portfolio, there are 15 properties (21% of total balance) located in California, 10 properties (8% of total balance) in % of Total Portfolio Michigan, 4 properties (7% of total balance) in Pennsylvania, 5 properties (7% of total balance) in Tennessee, 1 property (6% of total balance) in Nevada, 6 properties (5% of total balance) in Florida, 3 properties (5% of total balance) in New York, 6 properties (5% of total balance) in Texas and 4 properties (4% of total balance) in Wisconsin. Other properties are located in the state of Wisconsin, Virginia, North Carolina, Hampshire, Missouri, Georgia, Utah, Kentucky, Massachusetts, Wyoming, Hawaii, Washington, New Jersey, Arizona, Alabama, Mississippi, South Carolina, Arkansas, Louisiana, Oregon, Ohio, Colorado, Indiana and Illinois.

Among all the assets in the portfolio, 1 assets (3% of total balance) had LTVs between 30% and 40%, 4 assets (11% of total balance) with LTVs between 40% and 50%, 12 assets (10% of total balance) with LTVs between 50% and 60%, 47 assets (62% of total balance) with LTVs between 60% and 70% and 6 assets (14% of total balance) with LTVs between 70% and 80%.







Most recent net operating income debt yield ranged from 0% to 17% with a weighted average NOI debt yield of 10.2%. NOI debt yield ranged from 0% to 17%. There were 1 assets (2% of total balance) with NOI debt yield between 0% and 2%, 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 10 assets (20% of total balance) with NOI debt yield between 6% and 8%, 28 assets (38% of total balance) with NOI debt yield between 8% and 10%, 8 assets (14% of total balance) with NOI debt yield between 10% and 12%, 13 assets (17% of total balance) with NOI debt yield between 12% and 14%, 5 assets (6% of total balance) with NOI debt yield between 14% and 16% and 3 assets (3% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR ranged from 0.0x to 3.0x. There were 66 assets (87.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (1.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 2 assets (8.2% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (3.0% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 2.4x.




DSCR (Current / Underwritten)



There are 66 assets (87.0% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.9% of total balance) with DSCR between 1.0x and 1.5x, 1 assets (1.9% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (6.3% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (3.0% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
