Transaction Summary

The transaction closed on Jun 11 2014 and matures in Jul 2024. The pool's current aggregate principal balance is \$766.6 million compared to \$829.5 million at close.

The largest loan of the pool (14.8%) is secured by Woodbridge Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Sears (24.80%) and Boscov's (16.67%). The second largest loan of the pool (7.0%) is secured by Montgomery Mall located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 88%. The major tenants included Macy's (19.65%) and Sears (15.28%). The third largest loan of the pool (6.4%) is secured by Pacific Design Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 65%. The major tenants included Cedars-Sinai Medical Center (5.83%) and Cedars-Sinai Medical Center (3.10%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.83% and 79 months as of 12/15/2020, respectively. There are a total of 70 loans and 170 properties in the portfolio. The appraisal LTV was approximately 73.6% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.80x. As of 12/15/2020, 1.85% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

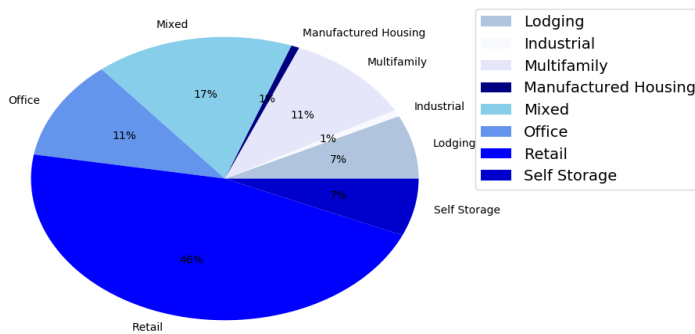

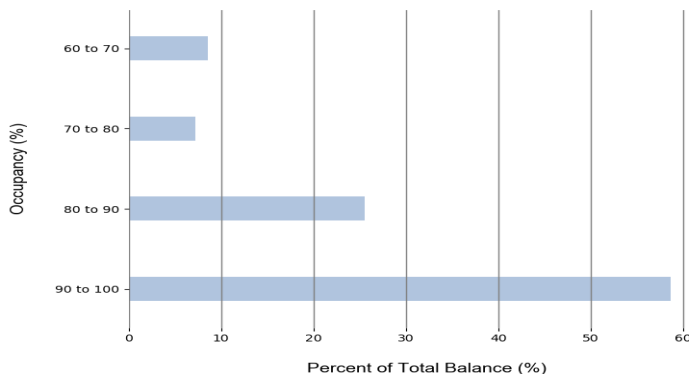

Occupancy Distribution (%)

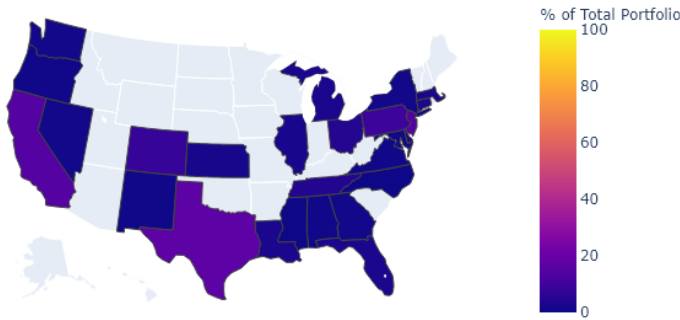

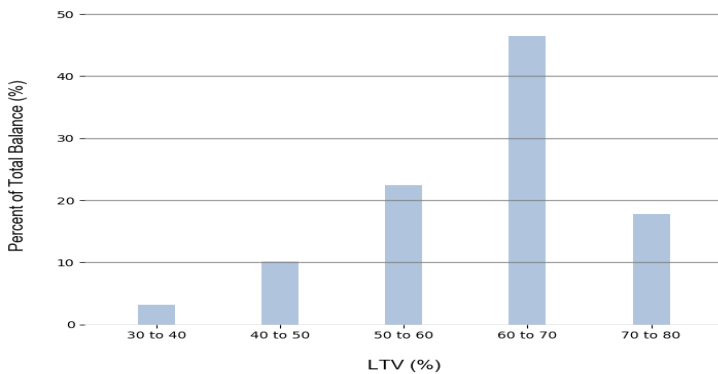
Local Distribution



Among assets in the portfolio, there are 14 properties (17% of total balance) located in Texas, 1 property (15% of total balance) in New Jersey, 11 properties (15% of total balance) in California, 2 properties (9% of total balance) in Pennsylvania, 7 properties (8% of total balance) in Colorado, 4 properties (5% of total balance) in Ohio, 5 properties (4% of total balance) in Tennessee and 6 properties (3% of total balance) in Connecticut. 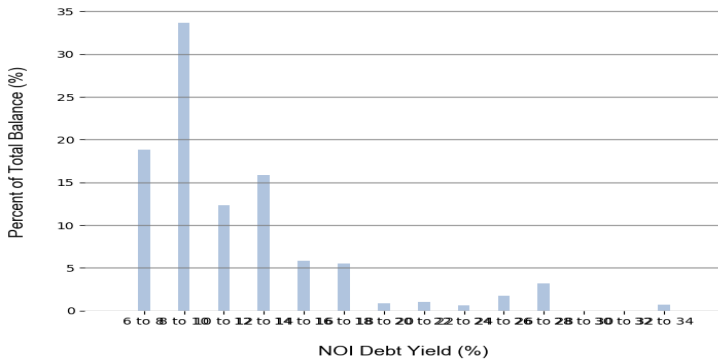

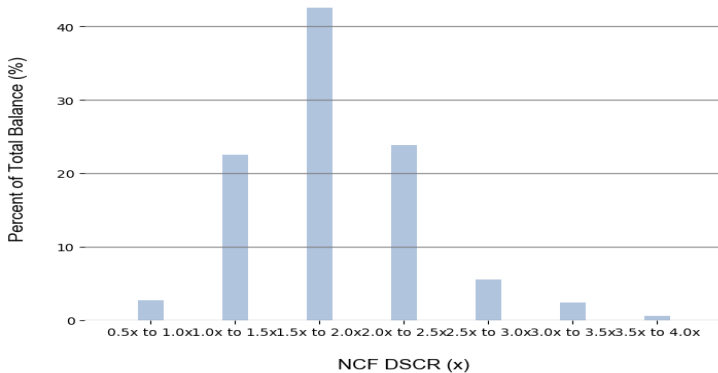
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 33% with a weighted average NOI debt yield of 11.8%. NOI debt yield ranged from 6% to 33%. Net Cash Flow DSCR (x)

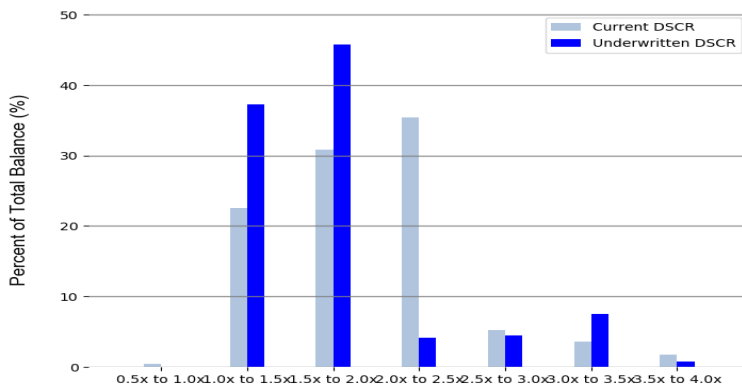


NCF DSCR ranged from 0.0x to 4.0x. There were 2 assets (2.6% of total balance) with NCF DSCR between 0.5x and 1.0x, 17 assets (22.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 26 assets (42.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (23.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (5.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 4 assets (2.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.6% of total balance) with NCF DSCR between 3.5x and 4.0x. 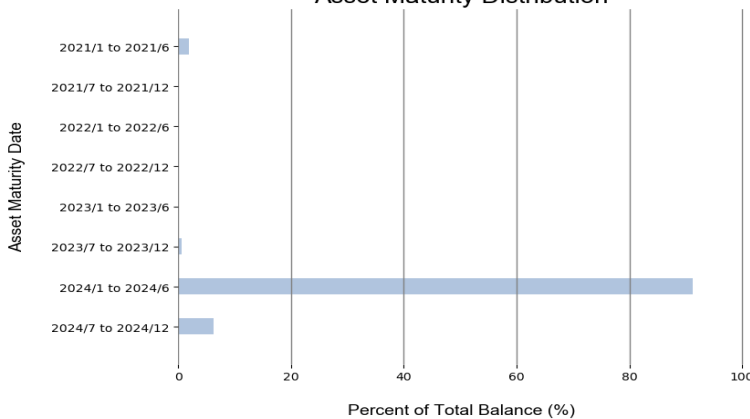
DSCR Distribution (x)



DSCRs ranged from 0.5x to 4.0x. There are 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 17 assets (22.6% of total balance) with DSCR between 1.0x and 1.5x, 25 assets (30.8% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (35.4% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (5.2% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (3.7% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (1.8% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.9x.

There are 1 assets (1.9% of total balance) that have maturity dates between 2021/1 and 2021/6, 1 assets (0.6% of total balance) that have maturity dates between 2023/7 and 2023/12, 67 assets (91.2% of total balance) that have maturity dates between 2024/1 and 2024/6 and 1 assets (6.4% of total balance) that have maturity dates between 2024/7 and 2024/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
