Transaction Summary

The transaction closed on Dec 30 2014 and matures in Dec 2044. The pool's current aggregate principal balance is \$972.8 million compared to \$1045.3 million at close.

The largest loan of the pool (8.6%) is secured by Hawaii Kai Towne Center located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Costco (29.56%) and EXTRA SPACE OF HONOLULU (25.54%). The second largest loan of the pool (4.6%) is secured by JW Marriott New Orleans located in metropolitan area. Occupancy at the subject was 84%. The third largest loan of the pool (3.9%) is secured by 2900 Fairview Park Drive located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The largest tenant was Hitt Construction (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.42% and 72 months as of 12/15/2020, respectively. There are a total of 90 loans and 104 properties in the portfolio. The appraisal LTV was approximately 61.1% compared to the Original loan to value (LTV), which was approximately 63.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.07x. As of 12/15/2020, 0.92% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

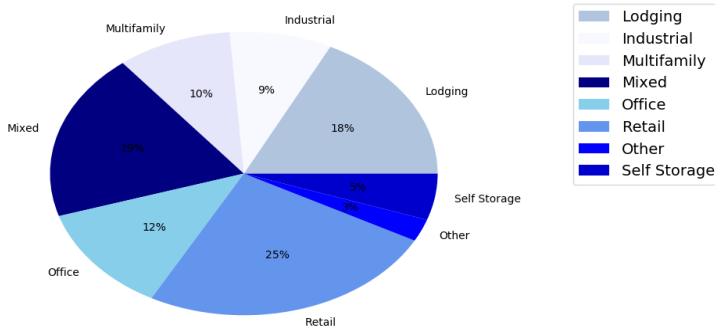

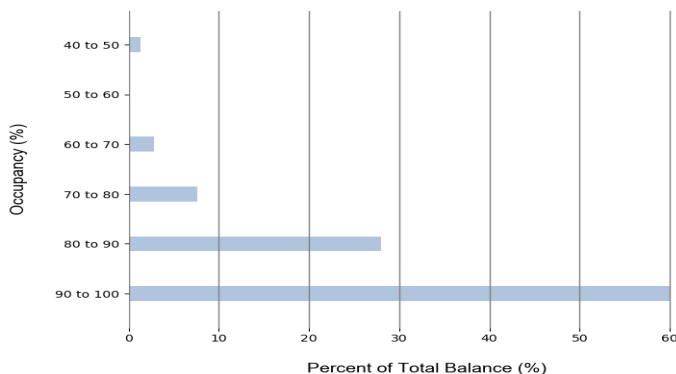

Occupancy Distribution (%)

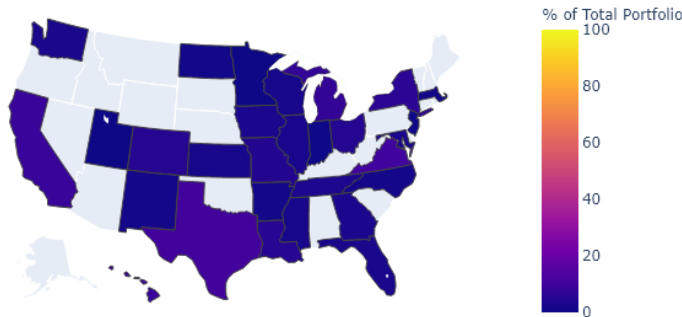

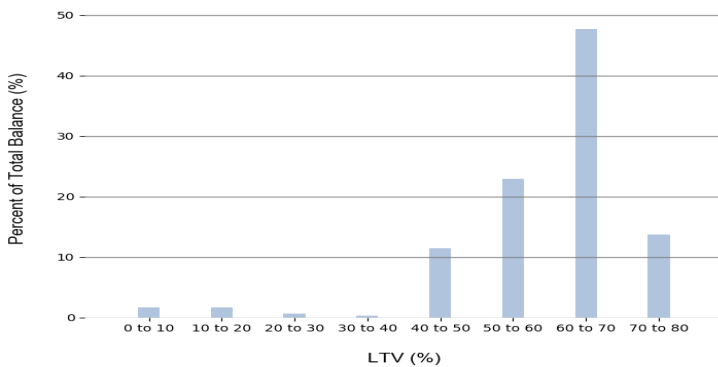
Local Distribution

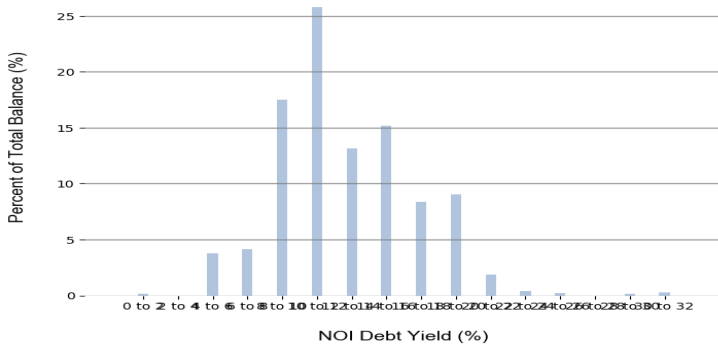

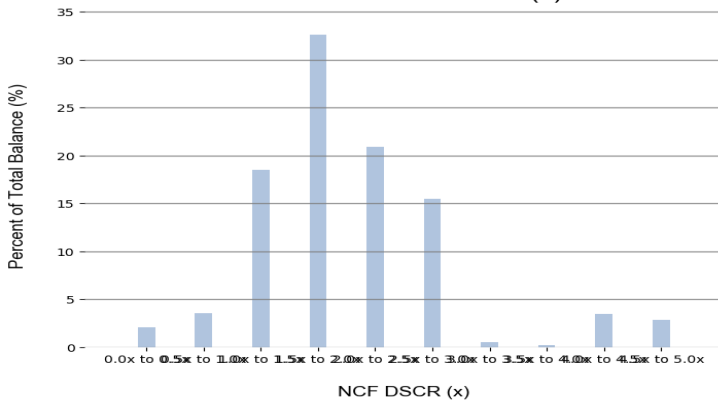
NOI Debt Yield (%)

NCF DSCR

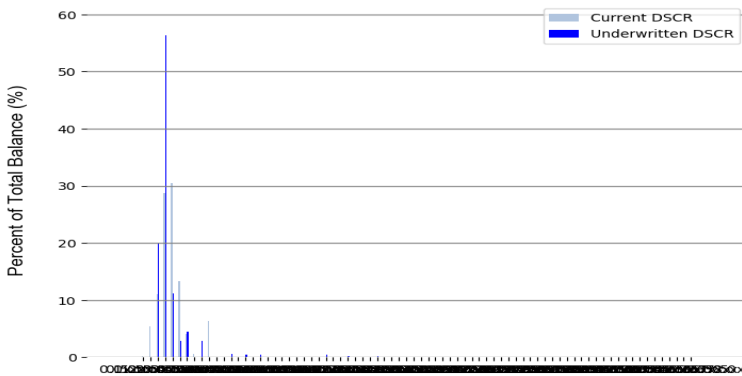
Net Cash Flow DSCR (x)

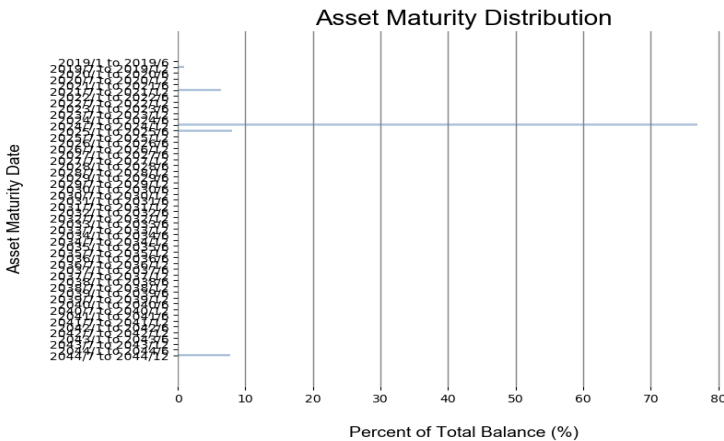

DSCRs ranged from 0.0x to 5.0x. There are 1 assets (0.1% of total balance) with DSCR between 0.0x and 0.5x, 7 assets (5.4% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (11.0% of total balance) with DSCR between 1.0x and 1.5x, 31 assets (28.7% of total balance) with DSCR between 1.5x and 2.0x, 21 assets (30.5% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (13.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (4.0% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x and 4 assets (6.3% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
