Transaction Summary

The transaction closed on Dec 30 2014 and matures in Dec 2044. The pool's current aggregate principal balance is \$927.9 million compared to \$1021.1 million at close.

The largest loan of the pool (8.8%) is secured by Hawaii Kai Towne Center located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Costco (29.56%) and EXTRA SPACE OF HONOLULU (25.54%). The second largest loan of the pool (4.6%) is secured by JW Marriott New Orleans located in metropolitan area. Occupancy at the subject was 35%. The third largest loan of the pool (4.0%) is secured by 2900 Fairview Park Drive located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The largest tenant was Hitt Construction (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.42% and 87 months as of 03/15/2022, respectively. There are a total of 87 loans and 101 properties in the portfolio. The appraisal LTV was approximately 59.9% compared to the Original loan to value (LTV), which was approximately 62.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.69x. As of 03/15/2022, 7.44% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from 0.0x to 5.5x. There are 3 assets (10.5% of total balance) with DSCR between 0.0x and 0.5x, 7 assets (5.9% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (10.2% of total balance) with DSCR between 1.0x and 1.5x, 36 assets (34.2% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (25.5% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (6.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.1% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (0.9% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.2% of total balance) with DSCR between 4.0x and 4.5x, 2 assets (6.1% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.3% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 1.8x.

There are 1 assets (8.0% of total balance) that have maturity dates between 2019/7 and 2019/12, 2 assets (61.0% of total balance) that have maturity dates between 2021/7 and 2021/12, 71 assets (708.2% of total balance) that have maturity dates between 2024/7 and 2024/12, 5 assets (76.0% of total balance) that have maturity dates between 2025/1 and 2025/6 and 8 assets (74.8% of total balance) that have maturity dates between 2044/7 and 2044/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
