Transaction Summary

The transaction closed on Feb 13 2015 and matures in Dec 2044. The pool's current aggregate principal balance is \$790.1 million compared to \$874.8 million at close.

The largest loan of the pool (5.1%) is secured by Chateau on the Lake located in metropolitan area. Occupancy at the subject was 30%. The second largest loan of the pool (5.0%) is secured by Trails at Dominion located in metropolitan area. Occupancy at the subject was 93%. The third largest loan of the pool (4.4%) is secured by JW Marriott New Orleans located in metropolitan area. Occupancy at the subject was 35%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.37% and 86 months as of 03/15/2022, respectively. There are a total of 92 loans and 106 properties in the portfolio. The appraisal LTV was approximately 61.0% compared to the Original loan to value (LTV), which was approximately 65.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.33x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 81%.

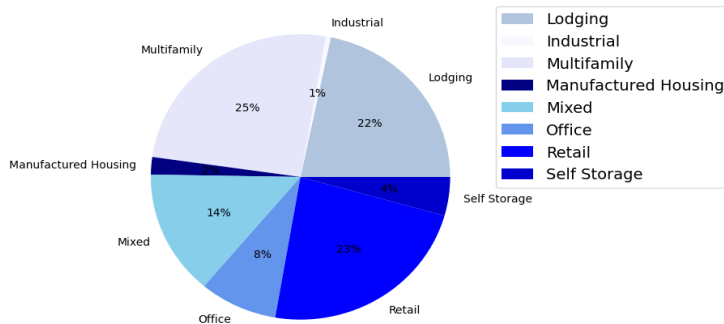

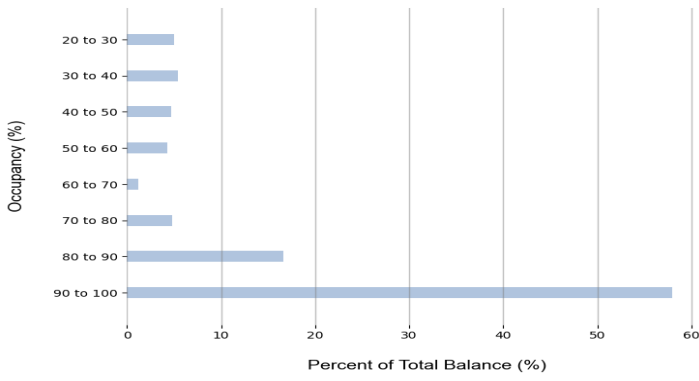

Occupancy Distribution (%)

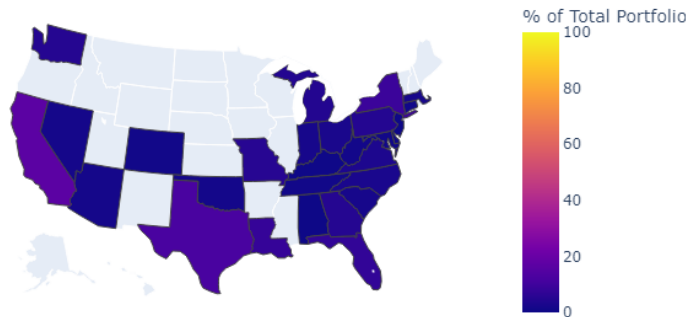

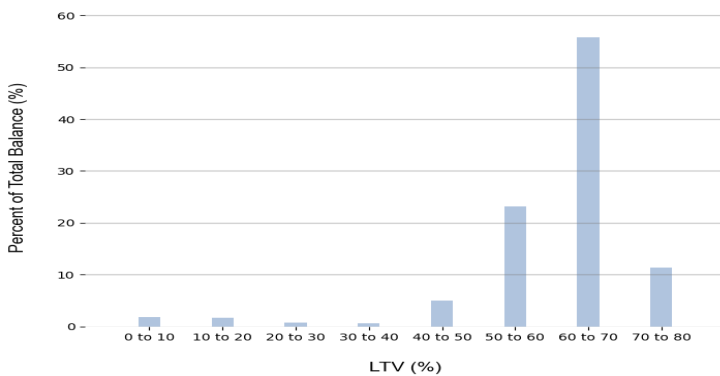
Local Distribution

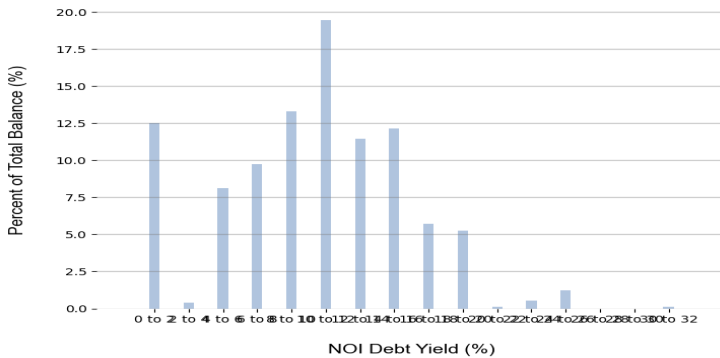

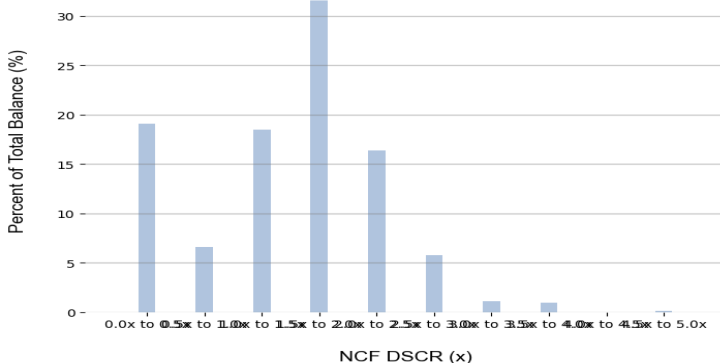
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 0% to 31% with a weighted average NOI debt yield of 10.2%. NOI debt yield ranged from 0% to 31%. 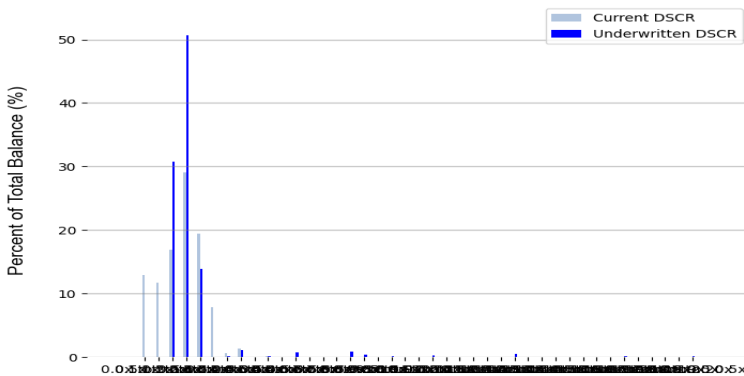
Net Cash Flow DSCR (x)

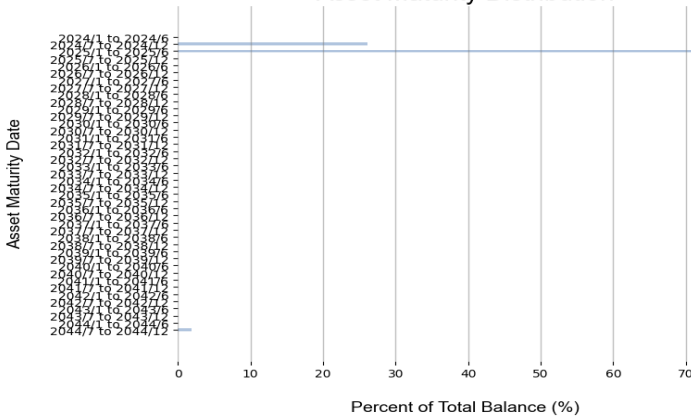
DSCR Distribution (x)



DSCRs ranged from 0.0x to 5.0x. There are 4 assets (12.9% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (11.7% of total balance) with DSCR between 0.5x and 1.0x, 17 assets (16.9% of total balance) with DSCR between 1.0x and 1.5x, 31 assets (29.1% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (19.4% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (7.9% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (0.6% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.1% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 1.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
