Transaction Summary

The transaction closed on Feb 13 2015 and matures in Dec 2044. The pool's current aggregate principal balance is \$788.7 million compared to \$874.8 million at close.

The largest loan of the pool (5.1%) is secured by Chateau on the Lake located in metropolitan area. Occupancy at the subject was 30%. The second largest loan of the pool (5.0%) is secured by Trails at Dominion located in metropolitan area. Occupancy at the subject was 93%. The third largest loan of the pool (4.4%) is secured by JW Marriott New Orleans located in metropolitan area. Occupancy at the subject was 35%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.37% and 87 months as of 04/15/2022, respectively. There are a total of 92 loans and 106 properties in the portfolio. The appraisal LTV was approximately 60.9% compared to the Original loan to value (LTV), which was approximately 65.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.34x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





Occupancy Distribution (%)






Local Distribution







DSCRs ranged from -0.5x to 5.0x. There are 1 assets (4.4% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (8.5% of total balance) with DSCR between 0.0x and 0.5x, 7 assets (9.3% of total balance) with DSCR between 0.5x and 1.0x, 19 assets (20.3% of total balance) with DSCR between 1.0x and 1.5x, 28 assets (26.7% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (19.5% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (8.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (1.3% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.1% of total balance) with DSCR between 4.5x and 5.0x. There are 22 assets (206.2% of total balance) that have maturity dates between 2024/7 and 2024/12, 69 assets (567.1% of total balance) that have maturity dates between 2025/1 and 2025/6 and 1 assets (15.4% of total balance) that have maturity dates between 2044/7 and 2044/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
