## **Transaction Summary**

The transaction closed on Mar 12 2015 and matures in Mar 2025. The pool's current aggregate principal balance is \$902.4 million compared to \$965.6 million at close.

The largest loan of the pool (6.9%) is secured by Westfield Palm Desert located in metropolitan area. Occupancy at the subject was 93%. The major tenants included Macy's (10.03%) and Dick's Clothing and Sporting Goods (8.16%). The second largest loan of the pool (5.3%) is secured by WP Carey Self Storage Portfolio VI located in Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-6.29% metropolitan area. Occupancy at the subject was 89%. The third largest loan of the pool (4.9%) is secured by 312 Elm located in metropolitan area. Occupancy at the subject was 64%. The major tenants included Gannett Satellite Info Network (28.81%) and USI Insurance Services (9.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.32% and 70 months as of 12/15/2020, respectively. There are a total of 84 loans and 112 properties in the portfolio. The appraisal LTV was approximately 63.4% compared to the Original loan to value (LTV), which was approximately 66.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





More specifically, 2 assets (3% of total balance) had the occupancy rate between 40% and 50%, 3 assets (7% of total balance) with the occupancy rate between 50% and 60%, 4 assets (6% of total balance) with the occupancy rate between 60% and 70%, 10 assets (12% of total balance) with the occupancy rate between 70% and 80%, 35 assets (26% of total balance) with the occupancy rate between 80% and 90% and 58 assets (46% of total balance) with the occupancy rate higher than 90%.




#### Local Distribution





Most recent net operating income debt yield ranged from -2% to 23% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from -2% to 23%. There were 1 assets (1% of total balance) with NOI debt yield between -2% and 0%, 1 assets (2% of total balance) with NOI debt yield between 2% and 4%, 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 6 assets (4% of total balance) with NOI debt yield between 6% and 8%, 11 assets (20% of total balance) with NOI debt yield between 8% and 10%, 22 assets (31% of total balance) with NOI debt yield between 10% and 12%, 18 assets (21% of total balance) with NOI debt yield between 12% and 14%, 14 assets (11% of total balance) with NOI debt vield between 14% and 16%. 8 assets (7% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 22% and 24%

There were 1 assets (0.6% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (1.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (5.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 21 assets (18.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 28 assets (38.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 20 assets (18.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (9.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.2% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (6.9% of total balance) with NCF DSCR between 3.5x and 4.0x. 



DSCRs ranged from -0.5x to 4.5x. There are 1 assets (0.6% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (1.9% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (4.7% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (11.7% of total balance) with DSCR between 1.0x and 1.5x, 30 assets (42.5% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (13.3% of total balance) with DSCR between 2.0x and 2.5x, 12 assets (17.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (6.9% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.1x.

# **Sensitivity Analysis**

## Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
