Transaction Summary

The transaction closed on Mar 12 2015 and matures in Mar 2025. The pool's current aggregate principal balance is \$822.1 million compared to \$899.8 million at close.

The largest loan of the pool (7.6%) is secured by Westfield Palm Desert located in metropolitan area. Occupancy at the subject was 93%. The major tenants included Macy's (10.03%) and Dick's Clothing and Sporting Goods (8.16%). The second largest loan of the pool (5.7%) is secured by WP Carey Self Storage Portfolio VI located in Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-6.29% metropolitan area. Occupancy at the subject was 96%. The third largest loan of the pool (5.2%) is secured by 312 Elm located in metropolitan area. Occupancy at the subject was 65%. The major tenants included Gannett Satellite Info Network (28.81%) and USI Insurance Services (9.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.31% and 85 months as of 03/15/2022, respectively. There are a total of 78 loans and 95 properties in the portfolio. The appraisal LTV was approximately 74.3% compared to the Original loan to value (LTV), which was approximately 66.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.63x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 79%.



Type Concentration











DSCRs ranged from -1.0x to 4.5x. There are 2 assets (2.8% of total balance) with DSCR between -1.0x and -0.5x, 2 assets (3.9% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (6.7% of total balance) with DSCR between 0.5x and 1.0x, 20 assets (23.5% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (27.3% of total balance) with DSCR between 1.5x and 2.0x, 19 assets (14.9% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (12.1% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.2% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (7.6% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 1.8x.

There are 13 assets (178.6% of total balance) that have maturity dates between 2024/7 and 2024/12 and 65 assets (643.6% of total balance) that have maturity dates between 2025/1 and 2025/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
