Transaction Summary

The transaction closed on May 21 2015 and matures in Apr 2045. The pool's current aggregate principal balance is \$1024.7 million compared to \$1073.1 million at close.

The largest loan of the pool (8.5%) is secured by TKG 2 Portfolio located in metropolitan area. Occupancy at the subject was 93%. The major tenants included Lowe's Home Improvement (15.29%) and Costco (14.96%). The second largest loan of the pool (8.3%) is secured by Harden Ranch Plaza located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Ashley Furniture Homestore (12.59%) and Safeway (12.49%). The third largest loan of the pool (7.2%) is secured by Eastgate One Phases I-VII & XII located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Lytx Inc. (14.71%) and SmartDrive Systems Inc. (7.37%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 68 months as of 12/15/2020, respectively. There are a total of 86 loans and 121 properties in the portfolio. The appraisal LTV was approximately 63.8% compared to the Original loan to value (LTV), which was approximately 65.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.26x. As of 12/15/2020, 1.27% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.







Region (by property)



Among assets in the portfolio, there are 10 properties (29% of total balance) located in California, 20 properties (11% of total balance) in Texas, 17 properties (11% of total balance) in Pennsylvania, 10 properties (6% of total balance) in Florida, 3 properties (5% of total balance) in Massachusetts, 1 property (4% of total balance) in Delaware, 5 properties (4% of total balance) in New Hampshire, 5 properties (4% of total balance) in New York and 2 properties (4% of total balance) in Louisiana. Other properties are located in the state of Louisiana, New Jersey, Michigan, Ohio, Colorado, Arizona, Washington, Nevada, Tennessee, Alabama, Virginia, Missouri, Illinois, Indiana, Montana, Maryland, North Dakota, Dakota, South Carolina, Georgia, South Mississippi, Oregon, Kentucky and Idaho.







Current DSCR



DSCRs ranged from 0.0x to 6.0x. There are 1 assets (1.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (0.4% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (6.2% of total balance) with DSCR between 1.0x and 1.5x, 35 assets (29.7% of total balance) with DSCR between 1.5x and 2.0x, 20 assets (34.8% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (3.0% of total balance) with DSCR between 2.5x and 3.0x, 6 assets (13.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.6% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (7.2% of total balance) with DSCR between 4.0x and 4.5x, 2 assets (0.9% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (1.0% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
