Transaction Summary

The transaction closed on Aug 12 2015 and matures in Jul 2035. The pool's current aggregate principal balance is \$664.6 million compared to \$726.4 million at close.

The largest loan of the pool (11.1%) is secured by Somerset Park Apartments located in Warren-Troy-Farmington Hills, MI metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (8.3%) is secured by Riverpark Square located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Nordstrom (34.44%) and AMC Cinema (21.58%). The third largest loan of the pool (5.6%) is secured by Simmons Tower located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Entergy Security Cushman and Wakefield (26.76%) and Mitchell Williams Office Se (7.83%).



Type Concentration







EJR's Key Rating Features & Differences Compared With Other NRSROs

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
