Transaction Summary

The transaction closed on Nov 12 2015 and matures in Sep 2026. The pool's current aggregate principal balance is \$910.5 million compared to \$950.5 million at close.

The largest loan of the pool (7.7%) is secured by 745 Atlantic Avenue located in Boston, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included WW 745 Atlantic (75.29%) and CAMBRIDGE ASSOCIATES LLC (17.67%). The second largest loan of the pool (6.6%) is secured by Sheraton Lincoln Harbor Hotel located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The third largest loan of the pool (4.9%) is secured by CityPlace I located in metropolitan area. Occupancy at the subject was 85%. The major tenants included United HealthCare (42.44%) and Bank Of America (7.46%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.62% and 62 months as of 12/15/2020, respectively. There are a total of 92 loans and 105 properties in the portfolio. The appraisal LTV was approximately 64.0% compared to the Original loan to value (LTV), which was approximately 66.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 6% to 31% with a weighted average NOI debt yield of 11.4%. NOI debt yield ranged from 6% to 31%. There were 3 assets (2.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 29 assets (30.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 31 assets (38.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 18 assets (18.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (4.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (1.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (3.3% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (0.5% of total balance) with NCF DSCR between 4.5x and 5.0x. 



There are 1 assets (0.4% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (13.5% of total balance) with DSCR between 1.0x and 1.5x, 40 assets (45.2% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (24.4% of total balance) with DSCR between 2.0x and 2.5x, 11 assets (9.5% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.2% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (0.9% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (3.3% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.5% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
