Transaction Summary

The transaction closed on Mar 31 2015 and matures in Mar 2045. The pool's current aggregate principal balance is \$744.5 million compared to \$783.5 million at close.

The largest loan of the pool (10.1%) is secured by 3 Columbus Circle located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included Young & Rubicam (30.31%) and EMERGE INC. (10.91%). The second largest loan of the pool (8.5%) is secured by Walgreens Portfolio located in Gary, IN-3.25% metropolitan area. Occupancy at the subject was 100%. The largest tenant was Walgreens (99.96%). The third largest loan of the pool (5.2%) is secured by One Monument Place located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 67%. The major tenants included TEOCO Corporation (18.84%) and Concept Plus LLC (6.27%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 70 months as of 12/15/2020, respectively. There are a total of 63 loans and 117 properties in the portfolio. The appraisal LTV was approximately 69.2% compared to the Original loan to value (LTV), which was approximately 67.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.70x. As of 12/15/2020, 6.12% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

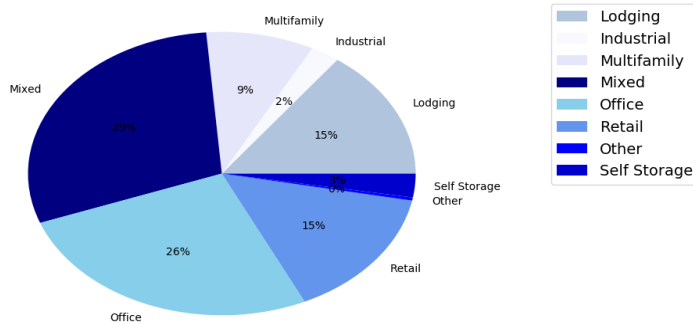

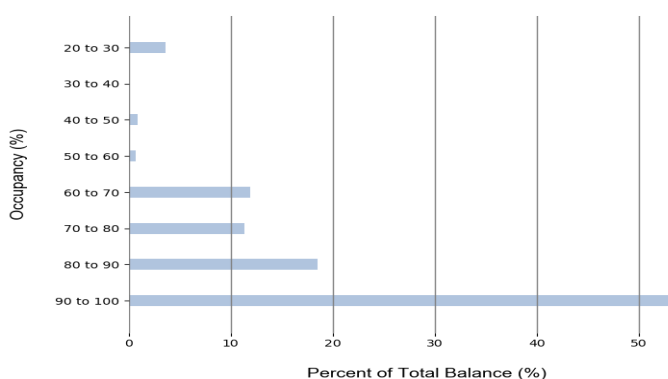

Occupancy Distribution (%)

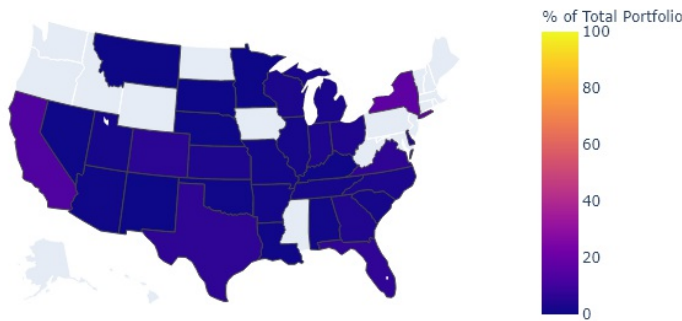

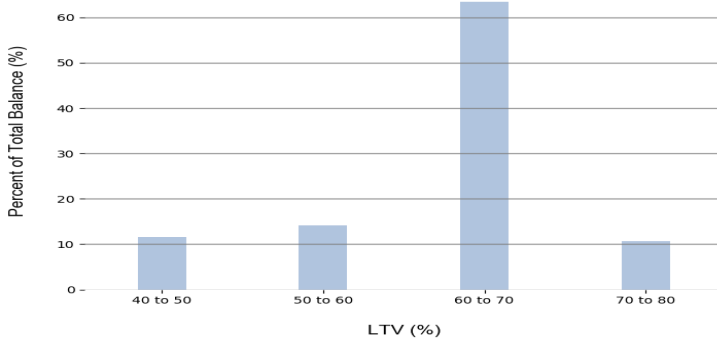
Local Distribution

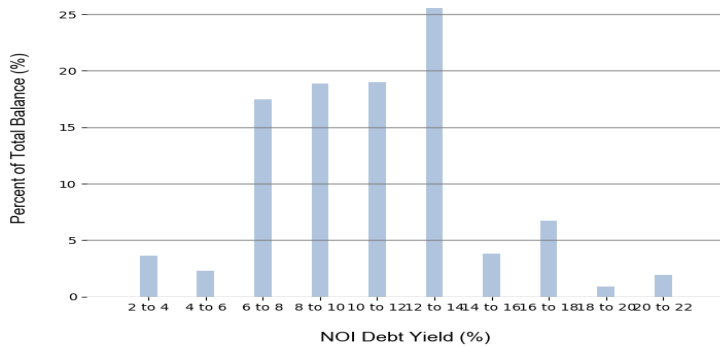

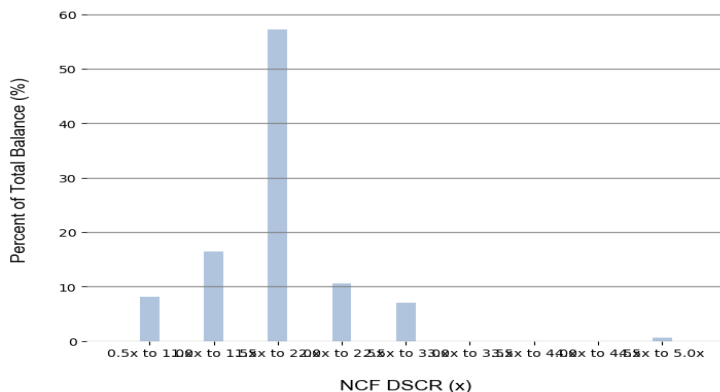
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 21% with a weighted average NOI debt yield of 10.7%. NOI debt yield ranged from 2% to 21%. There were 1 assets (4% of total balance) with NOI debt yield between 2% and 4%, 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 4 assets (17% of total balance) with NOI debt yield between 6% and 8%, 8 assets (19% of total balance) with NOI debt yield between 8% and 10%, 19 assets (19% of total balance) with NOI debt yield between 10% and 12%, 17 assets (26% of total balance) with NOI debt yield between 12% and 14%, 5 assets (4% of total balance) with NOI debt yield between 14% and 16%, 5 assets (7% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20% and 2 assets (2% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

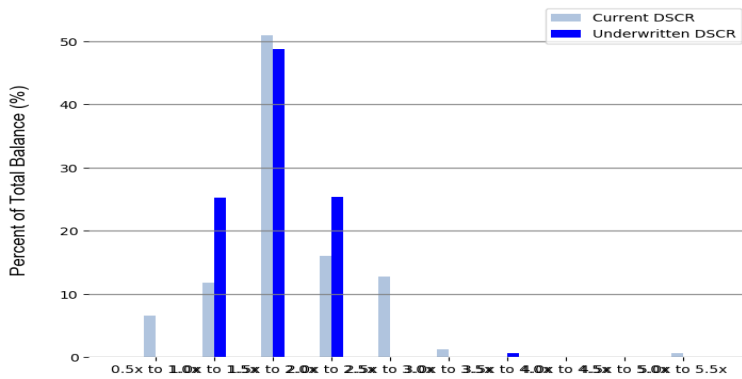


NCF DSCR ranged from 0.0x to 5.0x. There were 4 assets (8.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (16.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 36 assets (57.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (10.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (7.0% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.7% of total balance) with NCF DSCR between 4.5x and 5.0x. 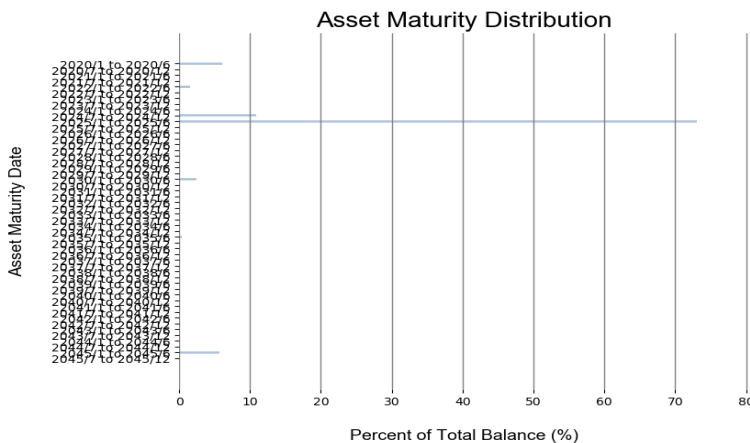

DSCRs ranged from 0.5x to 5.5x. There are 3 assets (6.6% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (11.8% of total balance) with DSCR between 1.0x and 1.5x, 31 assets (50.9% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (16.0% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (12.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.7% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 1.9x.

There are 2 assets (6.1% of total balance) that have maturity dates between 2020/1 and 2020/6, 1 assets (1.5% of total balance) that have maturity dates between 2022/1 and 2022/6, 3 assets (10.8% of total balance) that have maturity dates between 2024/7 and 2024/12, 47 assets (73.0% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (2.5% of total balance) that have maturity dates between 2030/1 and 2030/6, 4 assets (0.4% of total balance) that have maturity dates between 2035/1 and 2035/6 and 5 assets (5.6% of total balance) that have maturity dates between 2045/1 and 2045/6.

Sensitivity Analysis

Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

SEC Rule 17g-7(a) Disclosure

Below are the disclosures as required by Paragraph (a) of Rule 17g-7.

1. The symbol in the rating scale used to denote the credit rating categories and notches within categories and the identity of the obligor, security, or money market instrument as required by Paragraph (a)(1)(ii)(A) of Rule 17g-7:

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.
- 4). Do not address whether the market value of the security will remain stable over time.
- 5). Are not exact measures of the probability of default but are instead expressions of the relative credit risk of issuers and debt instruments.
- 6). Are not recommendations to buy, sell or hold any security.

5. Information on the uncertainty of the credit rating as required by Paragraph (a)(1)(ii)(E) of Rule 17g-7:

EJR's rating is dependent on numerous factors including the reliability, accuracy, and quality of the data used in determining the credit rating. The data is sourced from issuers' publicly disclosed reports, or from third-party data vendors. For solicited rating reports, EJR may also use the information provided by the client. In some cases, the information is limited because of issues such as the lack of reported data. Such shortcomings are not always readily apparent. EJR aims to identify such shortcomings and make adjustments using its best judgement.
