## **Transaction Summary**

The transaction closed on Mar 31 2015 and matures in Mar 2045. The pool's current aggregate principal balance is \$718.4 million compared to \$777.3 million at close.

The largest loan of the pool (10.4%) is secured by 3 Columbus Circle located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included Young & Rubicam (30.31%) and EMERGE INC. (10.91%). The second largest loan of the pool (8.6%) is secured by Walgreens Portfolio located in Gary, IN-3.25% metropolitan area. Occupancy at the subject was 100%. The largest tenant was Walgreens (99.96%). The third largest loan of the pool (4.5%) is secured by One Monument Place located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 53%. The major tenants included TEOCO Corporation (11.56%) and Broadspire Entity of Crawford and Co (4.28%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 86 months as of 04/15/2022, respectively. There are a total of 62 loans and 116 properties in the portfolio. The appraisal LTV was approximately 66.4% compared to the Original loan to value (LTV), which was approximately 67.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.64x. As of 04/15/2022, 11.48% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





### Occupancy Distribution (%)




#### Local Distribution









DSCRs ranged from -0.5x to 5.5x. There are 1 assets (1.0% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (8.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (5.7% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (5.1% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (42.2% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (18.2% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (13.9% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (4.0% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.9% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.7% of total balance) with DSCR between 5.0x and 5.5x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
