Transaction Summary

The transaction closed on Sep 29 2015 and matures in Sep 2030. The pool's current aggregate principal balance is \$864.4 million compared to \$917.8 million at close.

The largest loan of the pool (9.4%) is secured by 40 Wall Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The major tenants included GREEN (7.41%) and Country Wide Insurance (7.33%). The second largest loan of the pool (10.6%) is secured by The Meadows located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included Sony (8.79%) and Shiseido Americas Corporation (8.79%). The third largest loan of the pool (8.1%) is secured by Somerset Park Apartments - Pari NonControlling I located in Warren-Troy-Farmington Hills, MI metropolitan area. Occupancy at the subject was 94%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 64 months as of 12/15/2020, respectively. There are a total of 96 loans and 102 properties in the portfolio. The appraisal LTV was approximately 60.8% compared to the Original loan to value (LTV), which was approximately 60.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 12/15/2020, 0.67% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

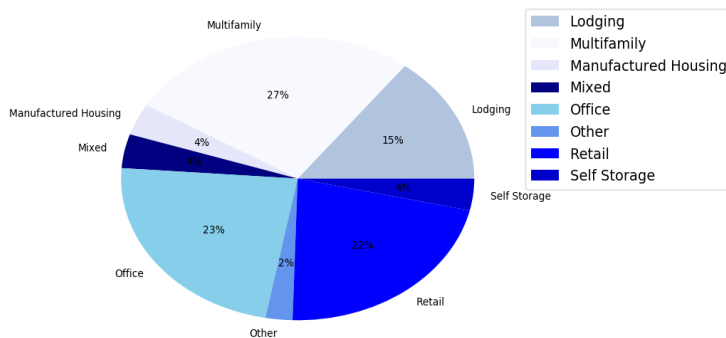

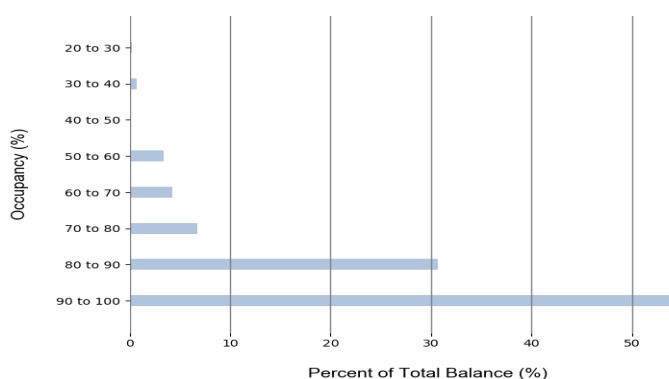

Occupancy Distribution (%)

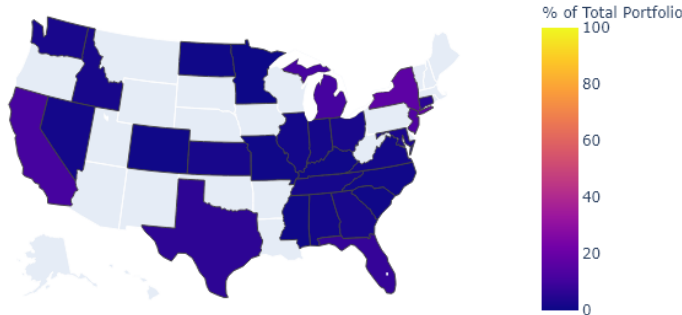

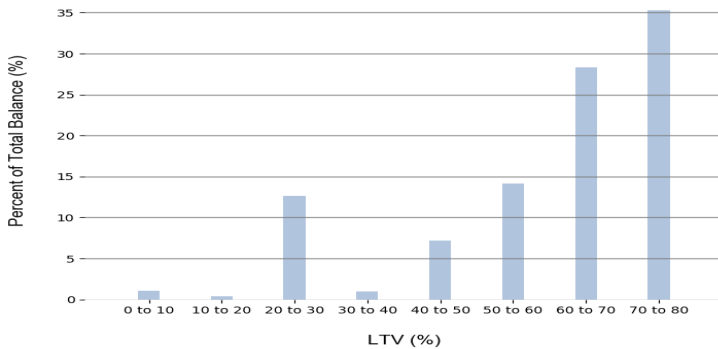
Local Distribution

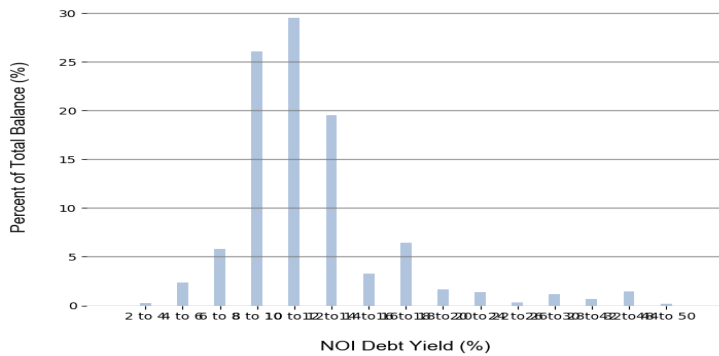

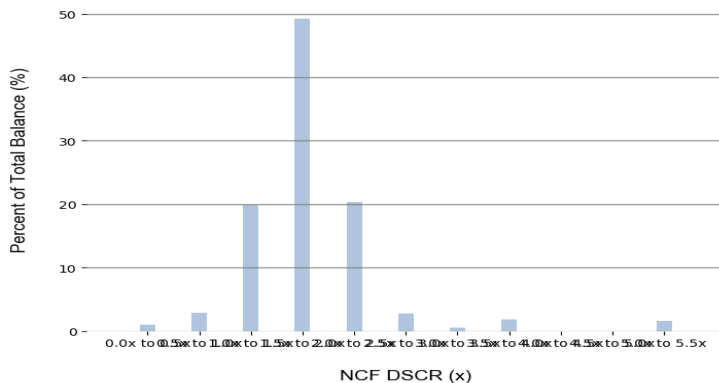
NOI Debt Yield (%)

NCF DSCR

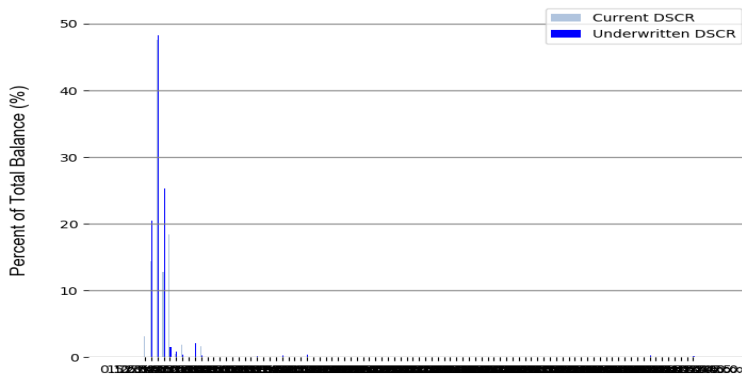
Net Cash Flow DSCR (x)

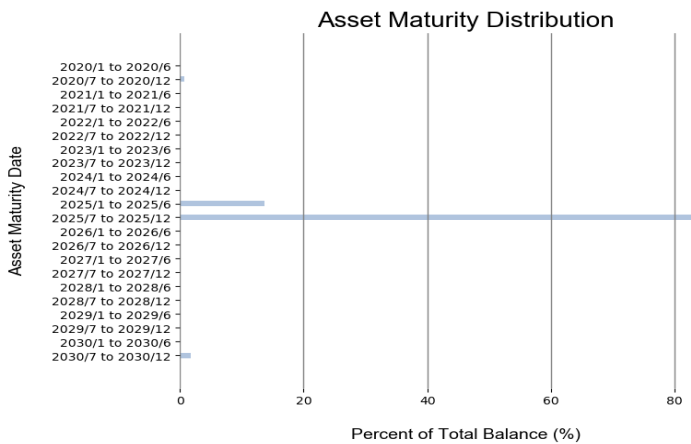

DSCRs ranged from 0.5x to 5.5x. There are 7 assets (3.1% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (14.3% of total balance) with DSCR between 1.0x and 1.5x, 40 assets (47.5% of total balance) with DSCR between 1.5x and 2.0x, 20 assets (12.8% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (18.4% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (0.5% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (1.8% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (1.6% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 2.0x.

There are 1 assets (0.7% of total balance) that have maturity dates between 2020/7 and 2020/12, 11 assets (13.6% of total balance) that have maturity dates between 2025/1 and 2025/6, 77 assets (83.9% of total balance) that have maturity dates between 2025/7 and 2025/12 and 7 assets (1.7% of total balance) that have maturity dates between 2030/7 and 2030/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
