## **Transaction Summary**

The transaction closed on Apr 29 2015 and matures in Apr 2035. The pool's current aggregate principal balance is \$729.4 million compared to \$795.1 million at close.

The largest loan of the pool (6.6%) is secured by Eastgate One Phases I-VII & XII located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Lytx Inc. (14.71%) and SmartDrive Systems Inc. (7.37%). The second largest loan of the pool (6.9%) is secured by Stanford Research Park located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Cooley LLP (100.00%). The third largest loan of the pool (4.8%) is secured by Mayfair in the Grove located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 100%. The major tenants included Sapient Corp. (19.24%) and GE (15.14%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.18% and 87 months as of 04/15/2022, respectively. There are a total of 60 loans and 85 properties in the portfolio. The appraisal LTV was approximately 63.3% compared to the Original loan to value (LTV), which was approximately 65.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.10x. As of 04/15/2022, 4.80% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.



Type Concentration









Net Cash Flow DSCR (x)





# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
