## **Transaction Summary**

The transaction closed on Jul 14 2015 and matures in Apr 2035. The pool's current aggregate principal balance is \$736.0 million compared to \$789.2 million at close.

The largest loan of the pool (8.2%) is secured by Campbell Technology Park located in metropolitan area. Occupancy at the subject was 76%. The major tenants included Dialog-Renesas (15.98%) and MOSS ADAMS (14.16%). The second largest loan of the pool (7.4%) is secured by Stor All Group Portfolio located in metropolitan area. Occupancy at the subject was 85%. The third largest loan of the pool (6.1%) is secured by 100 West 57th Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was GEORGETOWN COMPANY (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.31% and 83 months as of 04/15/2022, respectively. There are a total of 59 loans and 73 properties in the portfolio. The appraisal LTV was approximately 64.8% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.40x. As of 04/15/2022, 6.11% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.



Type Concentration






#### Local Distribution

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
