## **Transaction Summary**

The transaction closed on Oct 13 2015 and matures in Oct 2025. The pool's current aggregate principal balance is \$531.8 million compared to \$566.8 million at close.

The largest loan of the pool (11.2%) is secured by Yosemite Resorts located in metropolitan area. Occupancy at the subject was 51%. The second largest loan of the pool (12.2%) is secured by Northline Commons located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Burlington Coat Factory (14.92%) and Conn's Appliance (9.31%). The third largest loan of the pool (8.3%) is secured by Hilton Nashville located in metropolitan area. Occupancy at the subject was 72%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.52% and 79 months as of 04/15/2022, respectively. There are a total of 48 loans and 51 properties in the portfolio. The appraisal LTV was approximately 55.4% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





#### Occupancy Distribution (%)






Among assets in the portfolio, there are 18 properties (47% of total balance) located in California, 14 properties (15% of total balance)





Most recent net operating income debt yield ranged from 2% to 53% with a weighted average NOI debt yield of 12.4%. NOI debt yield ranged from 2% to 53%. There were 2 assets (1.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (5.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (16.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (54.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (10.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (1.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x, 2 assets (7.1% of total balance) with NCF DSCR between 4.5x and 5.0x and 1 assets (2.3% of total balance) with NCF DSCR between 5.5x and 6.0x. 



There are 1 assets (0.6% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (2.9% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (18.4% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (54.4% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (6.6% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (6.6% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (7.1% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (2.3% of total balance) with DSCR between 5.5x and 6.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
