Transaction Summary

The transaction closed on Dec 09 2015 and matures in Nov 2025. The pool's current aggregate principal balance is \$611.4 million compared to \$637.1 million at close.

The largest loan of the pool (7.4%) is secured by Renaissance Phoenix Downtown located in metropolitan area. Occupancy at the subject was 72%. The second largest loan of the pool (7.8%) is secured by Robertson's Creek Shopping Center located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 96%. The major tenants included Belk's (29.18%) and Hobby Lobby (16.74%). The third largest loan of the pool (5.8%) is secured by WPC Self Storage VIII located in metropolitan area. Occupancy at the subject was 89%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.71% and 62 months as of 12/15/2020, respectively. There are a total of 57 loans and 68 properties in the portfolio. The appraisal LTV was approximately 64.7% compared to the Original loan to value (LTV), which was approximately 65.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

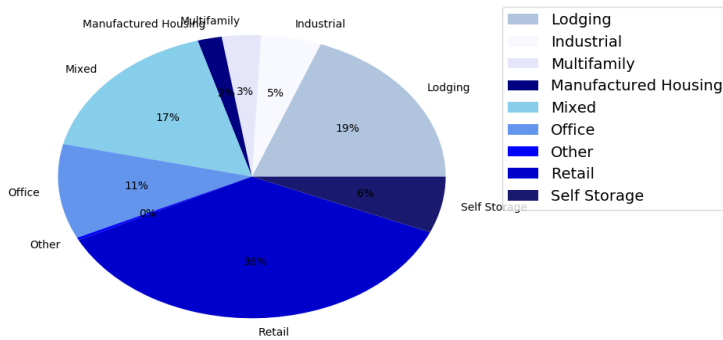

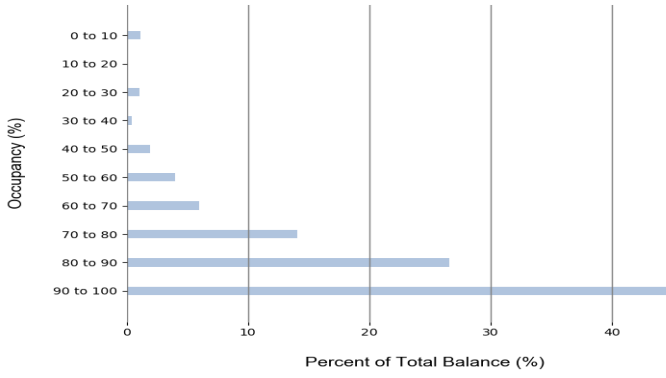

Occupancy Distribution (%)

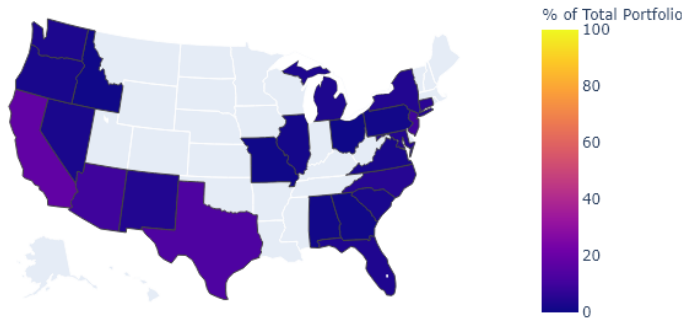

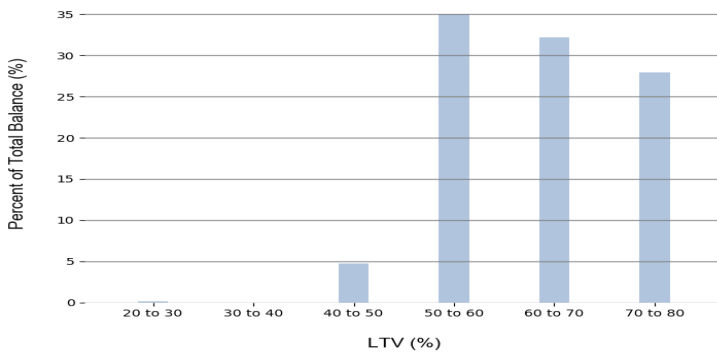
Local Distribution

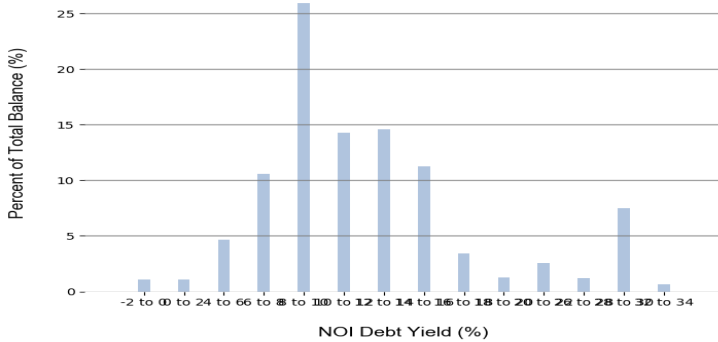

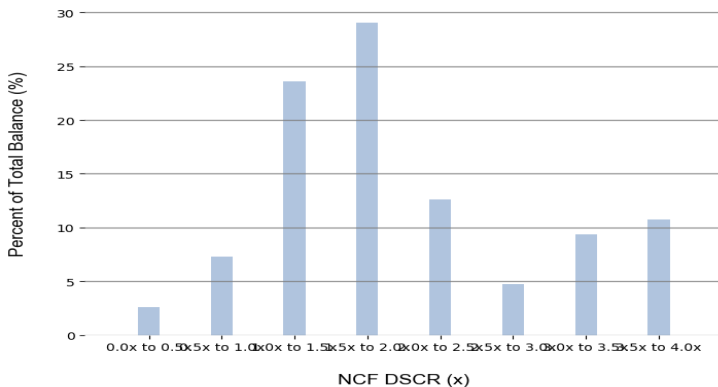
NOI Debt Yield (%)

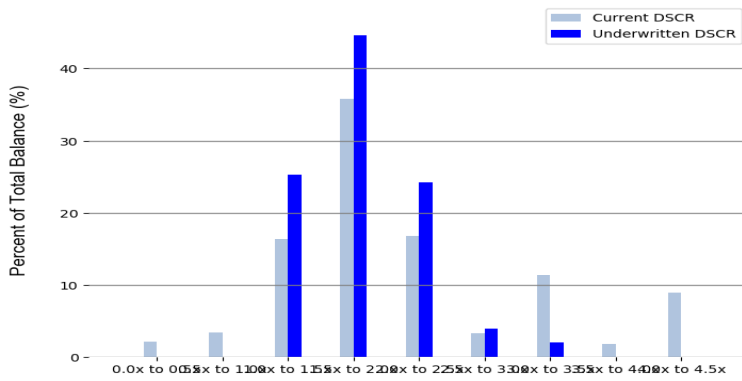

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
