# **Transaction Summary**

The transaction closed on Dec 09 2015 and matures in Nov 2025. The pool's current aggregate principal balance is \$591.1 million compared to \$627.1 million at close.

The largest loan of the pool (7.4%) is secured by Renaissance Phoenix Downtown located in metropolitan area. Occupancy at the subject was 27%. The second largest loan of the pool (8.0%) is secured by Robertson's Creek Shopping Center located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 93%. The major tenants included Belk's (29.18%) and Hobby Lobby (16.74%). The third largest loan of the pool (6.0%) is secured by WPC Self Storage VIII located in metropolitan area. Occupancy at the subject was 93%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 77 months as of 03/15/2022, respectively. There are a total of 55 loans and 66 properties in the portfolio. The appraisal LTV was approximately 63.6% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.47x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 76%.





#### Occupancy Distribution (%)













# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
