Transaction Summary

The transaction closed on Dec 23 2015 and matures in Dec 2030. The pool's current aggregate principal balance is \$852.5 million compared to \$881.5 million at close.

The largest loan of the pool (8.5%) is secured by Empire Mall located in metropolitan area. Occupancy at the subject was 78%. The major tenants included JC Penney (11.94%) and Macy's (8.96%). The second largest loan of the pool (6.9%) is secured by Pineapple Hotel Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 74%. The third largest loan of the pool (4.7%) is secured by Adler Office located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 87%. The major tenants included Florida Dept Of Revenue (10.57%) and Miami-Dade County Health Dept. (4.83%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.71% and 61 months as of 12/15/2020, respectively. There are a total of 69 loans and 84 properties in the portfolio. The appraisal LTV was approximately 61.1% compared to the Original loan to value (LTV), which was approximately 63.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.07x. As of 12/15/2020, 0.32% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.






Local Distribution





There were 1 assets (0.2% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (0.6% of total balance) with NCF DSCR between 0.5x and 1.0x, 18 assets (23.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (33.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (19.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (14.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (4.2% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (4.1% of total balance) with NCF DSCR between 4.5x and 5.0x. 



There are 1 assets (0.2% of total balance) with DSCR between 0.0x and 0.5x, 13 assets (16.9% of total balance) with DSCR between 1.0x and 1.5x, 29 assets (38.3% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (17.8% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (14.4% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (4.0% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (0.8% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (3.4% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (4.1% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
