Transaction Summary

The transaction closed on Aug 27 2015 and matures in Dec 2044. The pool's current aggregate principal balance is \$630.3 million compared to \$687.5 million at close.

The largest loan of the pool (9.7%) is secured by Patrick Henry Mall located in metropolitan area. Occupancy at the subject was 97%. The major tenants included JC Penney (19.71%) and Dick's Clothing and Sporting Goods (11.62%). The second largest loan of the pool (6.8%) is secured by Boca Park Marketplace located in metropolitan area. Occupancy at the subject was 88%. The major tenants included DRESS FOR LESS (20.69%) and Lamps Plus (7.50%). The third largest loan of the pool (5.6%) is secured by Fifth Third Center located in metropolitan area. Occupancy at the subject was 56%. The major tenants included Naples Business Suites LLC (11.70%) and Fifth Third Bank (11.49%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.51% and 80 months as of 03/15/2022, respectively. There are a total of 67 loans and 72 properties in the portfolio. The appraisal LTV was approximately 65.6% compared to the Original loan to value (LTV), which was approximately 66.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.45x. As of 03/15/2022, 1.06% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from -0.5x to 4.5x. There are 1 assets (4.7% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (5.2% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (10.3% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (28.6% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (16.6% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (20.7% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (8.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (2.2% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (2.0% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.3% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (6.7% of total balance) that have maturity dates between 2022/7 and 2022/12, 27 assets (187.7% of total balance) that have maturity dates between 2025/1 and 2025/6, 38 assets (431.6% of total balance) that have maturity dates between 2025/7 and 2025/12 and 1 assets (4.3% of total balance) that have maturity dates between 2044/7 and 2044/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
