Transaction Summary

The transaction closed on Aug 18 2016 and matures in Jul 2031. The pool's current aggregate principal balance is \$840.9 million compared to \$872.5 million at close.

The largest loan of the pool (9.5%) is secured by The Shops at Crystals - Trust located in metropolitan area. Occupancy at the subject was 80%. The major tenants included Louis Vuitton (8.67%) and Prada (5.92%). The second largest loan of the pool (9.5%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The major tenants included Vertex Pharmaceuticals Inc. (95.47%) and Bright Horizons Centers (1.12%). The third largest loan of the pool (7.7%) is secured by One Stamford Forum located in metropolitan area. Occupancy at the subject was 100%. The major tenants included UBS (66.89%) and Purdue Pharma LP (33.11%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.28% and 51 months as of 10/15/2020, respectively. There are a total of 40 loans and 46 properties in the portfolio. The appraisal LTV was approximately 53.9% compared to the Original loan to value (LTV), which was approximately 55.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.63x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 6% to 31% with a weighted average NOI debt yield of 13.3%. NOI debt yield ranged from 6% to 31%. There were 2 assets (5% of total balance) with NOI debt yield between 6% and 8%, 6 assets (20% of total balance) with NOI debt yield between 8% and 10%, 13 assets (24% of total balance) with NOI debt yield between 10% and 12%, 10 assets (15% of total balance) with NOI debt yield between 12% and 14%, 2 assets (10% of total balance) with NOI debt yield between 14% and 16%, 2 assets (5% of total balance) with NOI debt yield between 16% and 18%, 2 assets (14% of total balance) with NOI debt yield between 18% and 20%, 1 assets (7% of total balance) with NOI debt yield between 20% and 22%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24%, 1 assets (0% of total balance) with NOI debt yield between 30% and 32%

There were 1 assets (0.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 7 assets (20.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (24.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (18.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (4.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (4.7% of total balance) with NCF DSCR between 3.0x and 3.5x, 2 assets (16.6% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (9.5% of total balance) with NCF DSCR between 6.0x and 6.5x. 



DSCRs ranged from 1.0x to 6.5x.There are 4 assets (16.0% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (25.7% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (17.7% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (14.3% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (7.1% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (9.5% of total balance) with DSCR between 6.0x and 6.5x. The most recent weighted average DSCR is 2.8x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
