Transaction Summary

The transaction closed on Aug 18 2016 and matures in Jul 2031. The pool's current aggregate principal balance is \$823.5 million compared to \$867.5 million at close.

The largest loan of the pool (9.7%) is secured by The Shops at Crystals - Trust located in metropolitan area. Occupancy at the subject was 78%. The major tenants included Louis Vuitton (8.67%) and Prada (5.92%). The second largest loan of the pool (9.7%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included Vertex Pharmaceuticals Inc. (95.47%) and Bright Horizons Centers (1.12%). The third largest loan of the pool (7.6%) is secured by One Stamford Forum located in metropolitan area. Occupancy at the subject was 100%. The major tenants included UBS (66.89%) and Purdue Pharma LP (33.11%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.27% and 68 months as of 03/15/2022, respectively. There are a total of 39 loans and 45 properties in the portfolio. The appraisal LTV was approximately 52.8% compared to the Original loan to value (LTV), which was approximately 55.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.10x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





Occupancy Distribution (%)




Local Distribution





There were 4 assets (15.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (9.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 4 assets (7.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (23.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (22.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (2.7% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (10.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (9.7% of total balance) with NCF DSCR between 6.0x and 6.5x. 



There are 3 assets (13.3% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.1% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (10.9% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (17.2% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (20.7% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (15.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (9.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.7% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (9.7% of total balance) with DSCR between 6.0x and 6.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
