## **Transaction Summary**

The transaction closed on Feb 18 2016 and matures in Dec 2035. The pool's current aggregate principal balance is \$882.2 million compared to \$923.4 million at close.

The largest loan of the pool (9.2%) is secured by North Dallas Retail Portfolio located in Dallas-Plano-Irving, TX-72.64% Fort Worth-Arlington, TX-27.36% metropolitan area. Occupancy at the subject was 96%. The major tenants included Safeway (46.36%) and Randall's (9.23%). The second largest loan of the pool (6.7%) is secured by Marriott Melville Long Island located in Nassau County-Suffolk County, NY metropolitan area. Occupancy at the subject was 73%. The third largest loan of the pool (5.7%) is secured by Technology Station located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Fish & Richardson P C (51.69%) and GoFundMe Inc. (20.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.74% and 60 months as of 12/15/2020, respectively. There are a total of 109 loans and 149 properties in the portfolio. The appraisal LTV was approximately 56.9% compared to the Original loan to value (LTV), which was approximately 58.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 12/15/2020, 2.11% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration





More specifically, 2 assets (1% of total balance) had the occupancy rate between 40% and 50%, 4 assets (2% of total balance) with the occupancy rate between 60% and 70%, 16 assets (19% of total balance) with the occupancy rate between 70% and 80%, 24 assets (18% of total balance) with the occupancy rate between 80% and 90% and 103 assets (60% of total balance) with the occupancy rate higher than 90%.



Among assets in the portfolio, there are 32 properties (17% of total balance) located in New York, 17 properties (12% of total balance) in Texas, 20 properties (10% of total balance) in Illinois, 5 properties (9% of total balance) in California, 8 properties (6% of total balance) in Florida, 14 properties (6% of total balance) in Indiana, 7 properties (6% of total balance) in Michigan, 4 properties (6% of total balance) in New Jersey and 1 property (3% of total balance) in Delaware. Other properties are located in the state of Delaware, Louisiana, New Mexico, Kansas, Nevada, Georgia, Kentucky, North Carolina, South Carolina, Ohio, Pennsylvania, Tennessee, I o w a, Arizona, Wisconsin, Oregon, Oklahoma, Utah, Colorado, Alabama, Maryland, Washington DC, Vermont, Massachusetts and Connecticut.

Among all the assets in the portfolio, 13 assets (4% of total balance) had LTVs between 0% and 10%, 12 assets (4% of total balance) with LTVs between 10% and 20%, 5 assets (2% of total balance) with LTVs between 20% and 30%, 1 assets (2% of total balance) with LTVs between 30% and 40%, 7 assets (3% of total balance) with LTVs between 40% and 50%, 14 assets (24% of total balance) with LTVs between 50% and 60%, 49 assets (52% of total balance) with LTVs between 60% and 70% and 8 assets (9% of total balance) with LTVs between 70% and 80%.







Most recent net operating income debt yield ranged from 2% to 29% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 2% to 29%. 



# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
