Transaction Summary

The transaction closed on May 24 2016 and matures in May 2026. The pool's current aggregate principal balance is \$668.0 million compared to \$698.7 million at close.

The largest loan of the pool (10.1%) is secured by Regent Portfolio located in New York-Jersey City-White Plains, NY-NJ-88.66% Newark, NJ-PA-6.11% Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-5.23% metropolitan area. Occupancy at the subject was 89%. The major tenants included St. Joseph Medical Center (6.85%) and Surgical Associates (5.37%). The second largest loan of the pool (8.8%) is secured by Congressional North Shopping Center & 121 Congressional Lane located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 96%. The major tenants included Bed Bath & Beyond (26.72%) and Aldi Food Store (14.10%). The third largest loan of the pool (6.2%) is secured by Hilton & Homewood Suites Philadelphia located in Philadelphia, PA metropolitan area. Occupancy at the subject was 75%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.05% and 55 months as of 10/15/2020, respectively. There are a total of 67 loans and 91 properties in the portfolio. The appraisal LTV was approximately 66.7% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.73x. As of 10/15/2020, 4.66% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

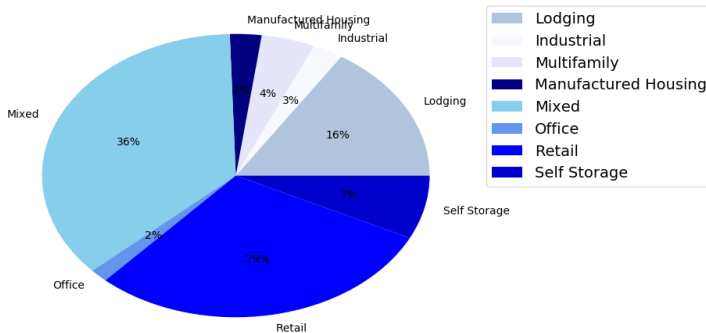

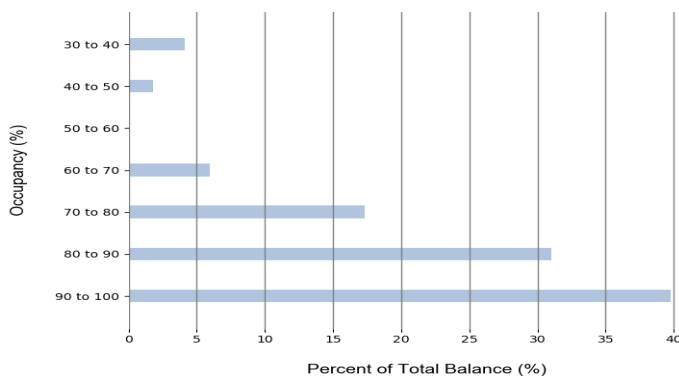

Occupancy Distribution (%)

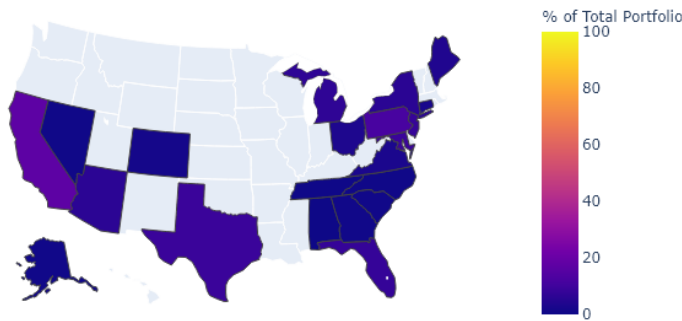

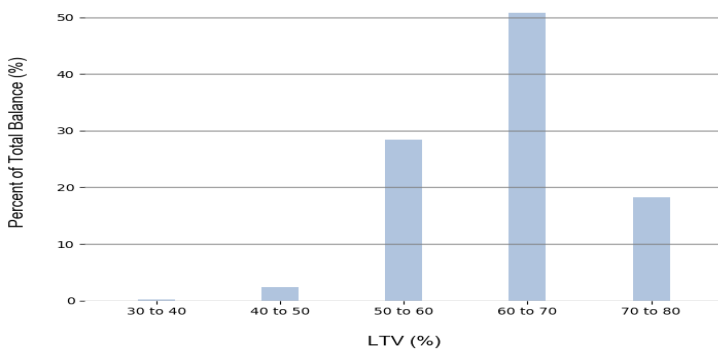
Local Distribution



Among assets in the portfolio, there are 12 properties (17% of total balance) located in California, 4 properties (12% of total balance) in Pennsylvania, 14 properties (9% of total balance) in Texas, 2 properties (9% of total balance) in Maryland, 11 properties (8% of total balance) in New Jersey, 10 properties (8% of total balance) in Florida, 5 properties (7% of total balance) in Michigan and 3 properties (6% of total balance) in Arizona. 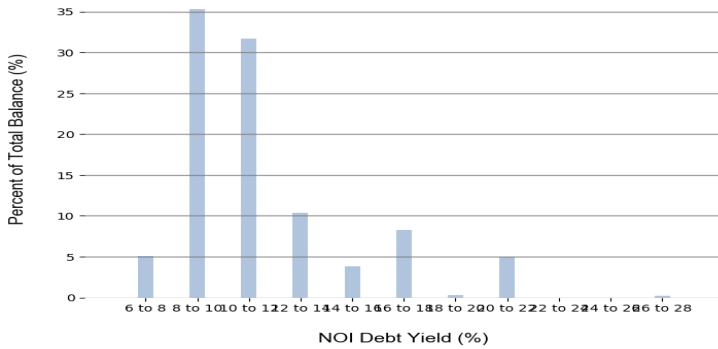

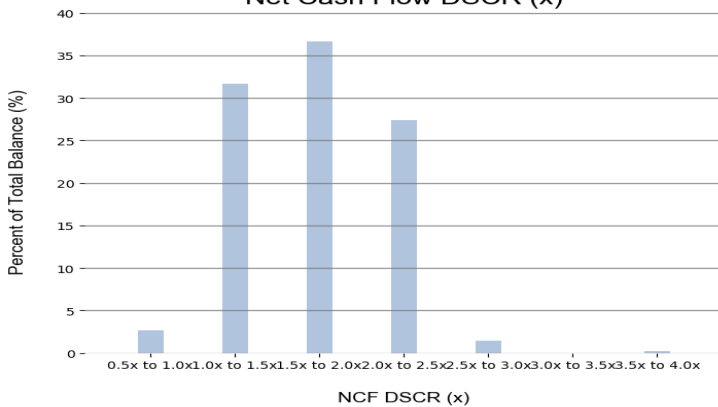
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

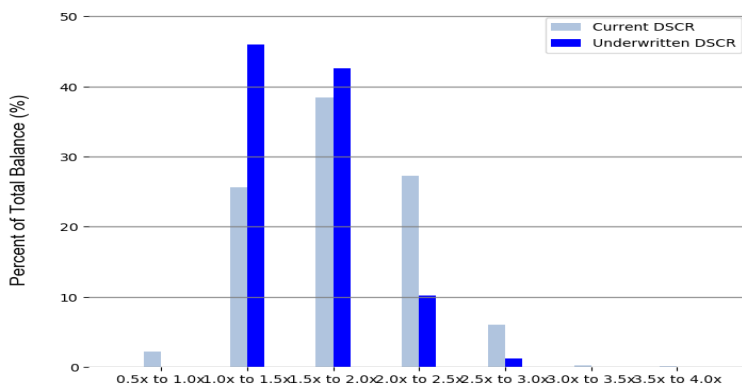


NCF DSCR ranged from 0.0x to 4.0x. There were 3 assets (2.6% of total balance) with NCF DSCR between 0.5x and 1.0x, 25 assets (31.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (36.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (27.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (1.4% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.2% of total balance) with NCF DSCR between 3.5x and 4.0x. 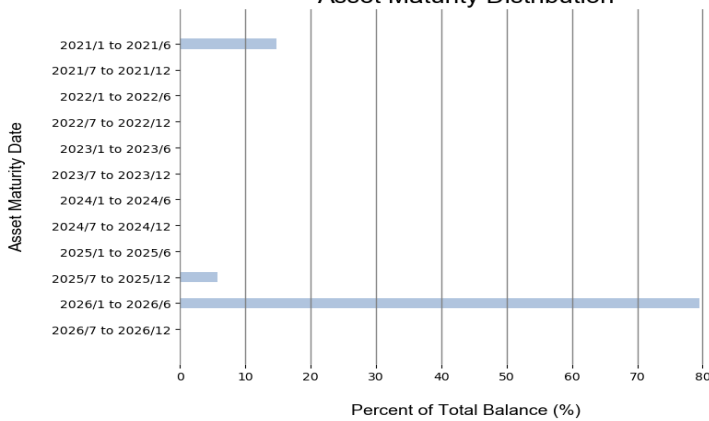
DSCR Distribution (x)



DSCRs ranged from 0.5x to 4.0x. There are 2 assets (2.2% of total balance) with DSCR between 0.5x and 1.0x, 22 assets (25.6% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (38.4% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (27.3% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (6.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.2% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
