Transaction Summary

The transaction closed on Jul 28 2016 and matures in Jul 2026. The pool's current aggregate principal balance is \$976.2 million compared to \$1023.8 million at close.

The largest loan of the pool (6.6%) is secured by Epps Bridge Centre located in metropolitan area. Occupancy at the subject was 96%. The major tenants included Dick's Clothing and Sporting Goods (14.86%) and Best Buy (8.91%). The second largest loan of the pool (6.1%) is secured by The Mall at Rockingham Park - Pooled located in Rockingham County-Strafford County, NH metropolitan area. Occupancy at the subject was 96%. The major tenants included Lord & Taylor (29.32%) and Forever21 (2.11%). The third largest loan of the pool (6.0%) is secured by Kroger (Roundy's) Distribution Center located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Roundy's (99.85%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.76% and 54 months as of 12/15/2020, respectively. There are a total of 102 loans and 178 properties in the portfolio. The appraisal LTV was approximately 61.7% compared to the Original loan to value (LTV), which was approximately 61.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.80x. As of 12/15/2020, 5.42% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.



Type Concentration





Occupancy Distribution (%)





Other properties are located in the state of Arkansas, Michigan, Florida, Connecticut, Virginia, Delaware, Tennessee, Pennsylvania, Kansas, Rhode Island, Arizona, Illinois, Minnesota, Alabama, Colorado, North Carolina, Louisiana, Maryland, Kentucky, Oklahoma, Iowa, Nevada, South Carolina, Washington, Montana, Utah and Massachusetts.

Among all the assets in the portfolio, 4 assets (1% of total balance) had LTVs between 0% and 10%, 6 assets (2% of total balance) with LTVs between 10% and 20%, 2 assets (6% of total balance) with LTVs between 20% and 30%, 7 assets (4% of total balance) with LTVs between 40% and 50%, 26 assets (27% of total balance) with LTVs between 40% and 50%, 26 assets (27% of total balance) with LTVs between 50% and 60%, 45 assets (49% of total balance) with LTVs between 60% and 70% and 12 assets (10% of total balance) with LTVs between 70% and 80%.

LTV Distribution (%)






DSCRs ranged from 0.0x to 4.0x. There are 1 assets (0.2% of total balance) with DSCR between 0.0x and 0.5x, 7 assets (5.4% of total balance) with DSCR between 0.5x and 1.0x, 18 assets (16.8% of total balance) with DSCR between 1.0x and 1.5x, 38 assets (43.8% of total balance) with DSCR between 1.5x and 2.0x, 16 assets (17.7% of total balance) with DSCR between 2.0x and 2.5x, 11 assets (5.8% of total balance) with DSCR between 2.0x and 3.5x and 3.0x, 5 assets (2.0% of total balance) with DSCR between 3.0x and 3.5x and 6 assets (8.3% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.9x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
