Transaction Summary

The transaction closed on Nov 03 2016 and matures in Nov 2026. The pool's current aggregate principal balance is \$820.0 million compared to \$859.2 million at close.

The largest loan of the pool (9.0%) is secured by Gurnee Mills located in Lake County-Kenosha County, IL-WI metropolitan area. Occupancy at the subject was 79%. The major tenants included Bass Pro Shops (8.15%) and Macy's (7.72%). The second largest loan of the pool (8.2%) is secured by 101 Hudson Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 76%. The major tenants included Merrill Lynch (28.94%) and FIRST DATA CORPORATION (5.99%). The third largest loan of the pool (7.9%) is secured by Plaza America I & II located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 92%. The major tenants included SOFTWARE AG GOVT SOLUTIONS INC (12.05%) and NVR, Inc. (11.88%).


The weighted average coupon (WAC) and the weighted average age (WALA) were 4.21% and 51 months as of 12/15/2020, respectively. There are a total of 73 loans and 104 properties in the portfolio. The appraisal LTV was approximately 57.5% compared to the Original loan to value (LTV), which was approximately 58.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.00x. As of 12/15/2020, 0.46% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.



Occupancy Distribution (%)




Local Distribution









There are 3 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 18 assets (30.2% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (21.0% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (16.1% of total balance) with DSCR between 2.0x and 2.5x, 15 assets (22.3% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.8% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (5.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (1.8% of total balance) with DSCR between 6.0x and 6.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
