Transaction Summary

The transaction closed on Dec 22 2016 and matures in Dec 2026. The pool's current aggregate principal balance is \$712.9 million compared to \$741.9 million at close.

The largest loan of the pool (7.4%) is secured by Hilton Hawaiian Village - Trust located in metropolitan area. Occupancy at the subject was 93%. The second largest loan of the pool (7.3%) is secured by Quantum Park located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The largest tenant was Verizon (100.00%). The third largest loan of the pool (5.4%) is secured by Walmart Shadow Anchored Portfolio located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Dollar Tree Stores (27.16%) and Cato (9.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.50% and 49 months as of 12/15/2020, respectively. There are a total of 62 loans and 140 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 62.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.23x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

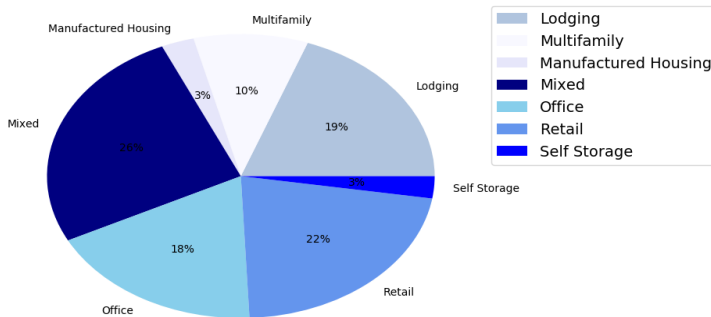

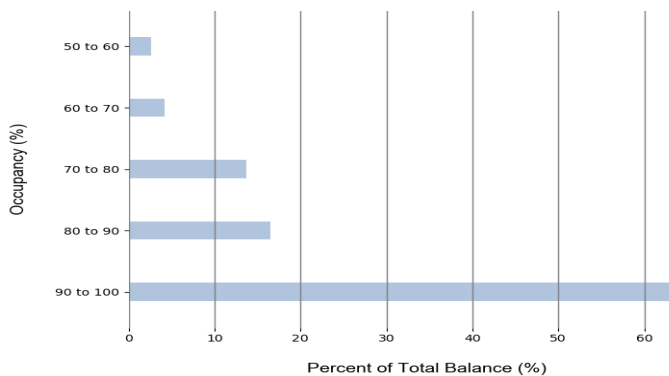

Occupancy Distribution (%)

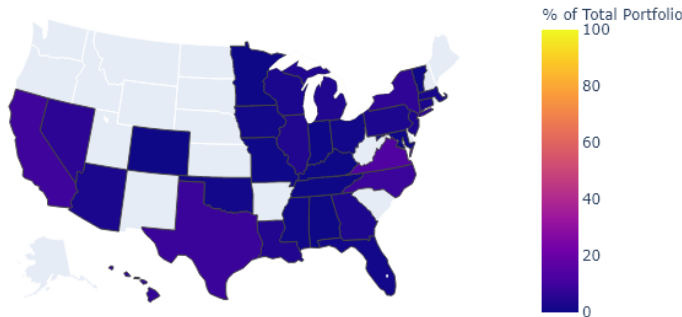

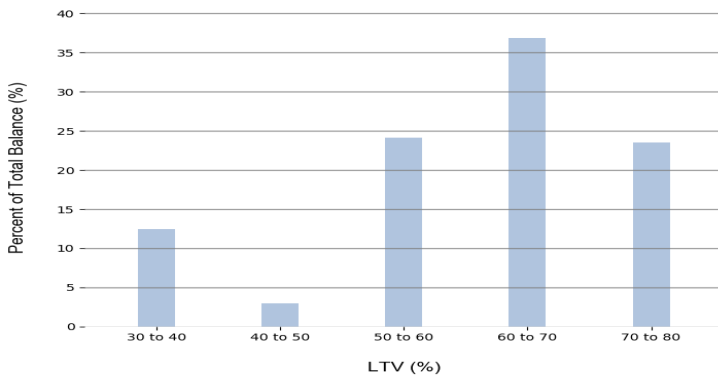
Local Distribution

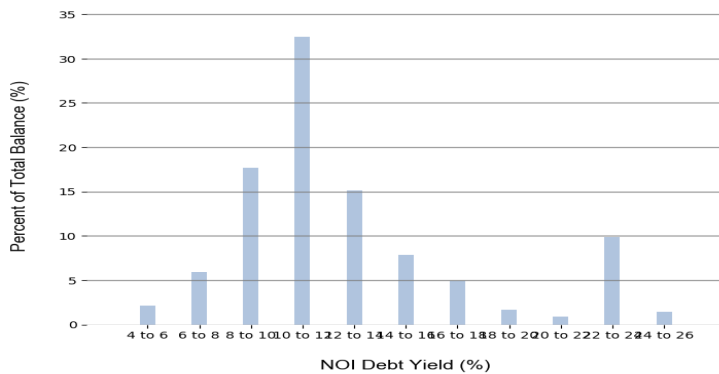

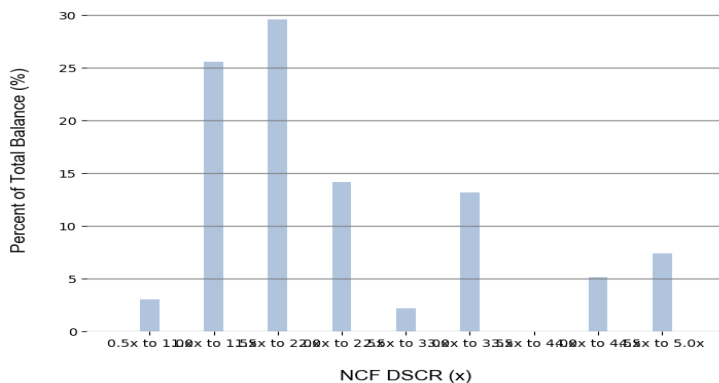
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 12.8%. NOI debt yield ranged from 4% to 25%. Net Cash Flow DSCR (x)

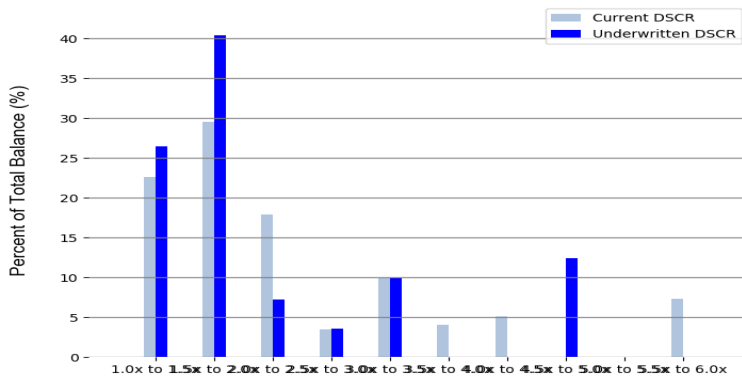


NCF DSCR ranged from 0.0x to 5.0x. There were 2 assets (3.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (25.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 26 assets (29.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (14.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 5 assets (13.2% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (5.1% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (7.4% of total balance) with NCF DSCR between 4.5x and 5.0x. 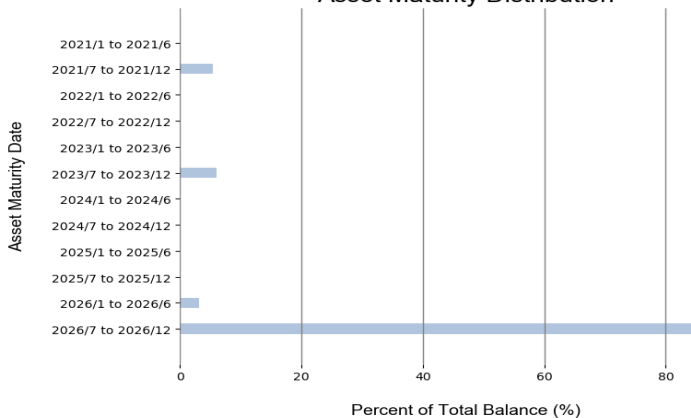
DSCR Distribution (x)



DSCRs ranged from 1.0x to 6.0x. There are 15 assets (22.6% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (29.5% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (17.9% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (3.4% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (9.9% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (4.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (5.1% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (7.4% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.4x.

There are 1 assets (5.4% of total balance) that have maturity dates between 2021/7 and 2021/12, 2 assets (6.0% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (3.1% of total balance) that have maturity dates between 2026/1 and 2026/6 and 58 assets (85.5% of total balance) that have maturity dates between 2026/7 and 2026/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
