Transaction Summary

The transaction closed on Sep 29 2016 and matures in Jul 2036. The pool's current aggregate principal balance is \$919.8 million compared to \$980.9 million at close.

The largest loan of the pool (6.9%) is secured by Central Park Retail located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 88%. The major tenants included Hobby Lobby (12.10%) and Office Depot (6.79%). The second largest loan of the pool (5.9%) is secured by Green Valley Portfolio located in New York-Jersey City-White Plains, NY-NJ-11.97% metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (5.1%) is secured by Four Points by Sheraton Times Square - Leased Fee located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.45% and 68 months as of 03/15/2022, respectively. There are a total of 86 loans and 120 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 61.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.50x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 51% with a weighted average NOI debt yield of 9.5%. NOI debt yield ranged from 0% to 51%. There were 3 assets (2% of total balance) with NOI debt yield between 0% and 2%, 3 assets (2% of total balance) with NOI debt yield between 2% and 4%, 8 assets (14% of total balance) with NOI debt vield between 4% and 6%, 7 assets (7% of total balance) with NOI debt yield between 6% and 8%, 18 assets (32% of total balance) with NOI debt yield between 8% and 10%, 24 assets (20% of total balance) with NOI debt yield between 10% and 12%, 11 assets (15% of total balance) with NOI debt yield between 12% and 14%, 7 assets (5% of total balance) with NOI debt yield between 14% and 16%, 3 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20% and 1 assets (0% of total balance) with NOI debt yield between 50% and 52%.

NCF DSCR ranged from 0.0x to 3.5x. There were 4 assets (3.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 11 assets (7.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 29 assets (52.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 23 assets (14.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 16 assets (15.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.9% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (3.8% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.5x.







DSCRs ranged from 0.0x to 3.5x.There are 4 assets (3.3% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (7.0% of total balance) with DSCR between 0.5x and 1.0x, 23 assets (42.5% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (21.5% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (12.5% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.3% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (3.8% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.6x

There are 1 assets (9.5% of total balance) that have maturity dates between 2022/7 and 2022/12, 3 assets (28.8% of total balance) that have maturity dates between 2025/7 and 2025/12, 16 assets (211.8% of total balance) that have maturity dates between 2026/1 and 2026/6, 60 assets (615.6% of total balance) that have maturity dates between 2026/7 and 2026/12, 1 assets (3.8% of total balance) that have maturity dates between 2030/1 and 2030/6, 3 assets (3.0% of total balance) that have maturity dates between 2031/1 and 2031/6, 1 assets (0.6% of total balance) that have maturity dates between 2031/7 and 2031/12 and 1 assets (46.7% of total balance) that have maturity dates between 2036/7 and 2036/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
