Transaction Summary

The transaction closed on Dec 08 2016 and matures in Nov 2031. The pool's current aggregate principal balance is \$908.0 million compared to \$940.8 million at close.

The largest loan of the pool (5.5%) is secured by 9 West 57th Street - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 76%. The major tenants included Kohlberg, Kravis, Roberts & Co. (11.67%) and Chanel Inc. (11.02%). The second largest loan of the pool (5.3%) is secured by Walmart Shadow Anchored Portfolio located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Dollar Tree Stores (27.16%) and Cato (9.06%). The third largest loan of the pool (4.3%) is secured by Marriott Hilton Head Resort & Spa located in metropolitan area. Occupancy at the subject was 58%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.44% and 48 months as of 10/15/2020, respectively. There are a total of 79 loans and 134 properties in the portfolio. The appraisal LTV was approximately 61.5% compared to the Original loan to value (LTV), which was approximately 63.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.69x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





Occupancy Distribution (%)




Local Distribution





There were 2 assets (0.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (1.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 27 assets (40.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 34 assets (38.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (9.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.3% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (7.1% of total balance) with NCF DSCR between 3.0x and 3.5x. 



DSCRs ranged from 0.0x to 3.5x.There are 2 assets (0.8% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.2% of total balance) with DSCR between 0.5x and 1.0x, 20 assets (27.3% of total balance) with DSCR between 1.0x and 1.5x, 37 assets (50.2% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (7.3% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (6.1% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (7.1% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.8x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
