Transaction Summary

The transaction closed on Feb 26 2016 and matures in Jan 2036. The pool's current aggregate principal balance is \$726.6 million compared to \$763.3 million at close.

The largest loan of the pool (10.3%) is secured by 10 South LaSalle Street located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Chicago Title Co. (13.55%) and The Northern Trust Company (10.28%). The second largest loan of the pool (6.4%) is secured by Chicago Industrial Portfolio II located in Elgin, IL-6.69% Lake County-Kenosha County, IL-WI-4.91% metropolitan area. Occupancy at the subject was 99%. The major tenants included Grane Distribution Services LLC (15.57%) and Budd Van Lines Inc (10.32%). The third largest loan of the pool (5.6%) is secured by Walgreens - CVS Portfolio located in Montgomery County-Bucks County-Chester County, PA-11.64% Camden, NJ-10.52% New York-Jersey City-White Plains, NY-NJ-10.32% metropolitan area. Occupancy at the subject was 100%. The largest tenant was Walgreens (92.01%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.00% and 59 months as of 12/15/2020, respectively. There are a total of 60 loans and 112 properties in the portfolio. The appraisal LTV was approximately 67.8% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.67x. As of 12/15/2020, 0.87% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration









EJR's Key Rating Features & Differences Compared With Other NRSROs

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
