## **Transaction Summary**

The transaction closed on Feb 26 2016 and matures in Jan 2036. The pool's current aggregate principal balance is \$706.2 million compared to \$756.5 million at close.

The largest loan of the pool (10.6%) is secured by 10 South LaSalle Street located in metropolitan area. Occupancy at the subject was 72%. The major tenants included Chicago Title Co. (13.55%) and AMWINS BROKERAGE OF ILLIONIS (7.44%). The second largest loan of the pool (6.5%) is secured by Chicago Industrial Portfolio II located in Elgin, IL-6.69% Lake County-Kenosha County, IL-WI-4.91% metropolitan area. Occupancy at the subject was 96%. The major tenants included Grane Distribution Services LLC (15.57%) and Budd Van Lines Inc (10.32%). The third largest loan of the pool (5.6%) is secured by Walgreens - CVS Portfolio located in Montgomery County-Bucks County-Chester County, PA-11.64% Camden, NJ-10.52% New York-Jersey City-White Plains, NY-NJ-10.32% metropolitan area. Occupancy at the subject was 100%. The largest tenant was Walgreens (92.01%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.00% and 74 months as of 03/15/2022, respectively. There are a total of 59 loans and 111 properties in the portfolio. The appraisal LTV was approximately 66.5% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.51x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





## Occupancy Distribution (%)




## Local Distribution





Most recent net operating income debt yield ranged from 4% to 33% with a weighted average NOI debt yield of 10.9%. NOI debt yield ranged from 4% to 33%. 



DSCRs ranged from 0.0x to 5.0x. There are 2 assets (2.1% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (13.8% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (28.0% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (31.2% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (18.2% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (2.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (1.5% of total balance) with DSCR between 3.0x and 3.5x, 4 assets (1.7% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.6% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.6% of total balance) with DSCR between 4.5x and 5.0x. There are 2 assets (36.4% of total balance) that have maturity dates between 2023/1 and 2023/6, 20 assets (163.9% of total balance) that have maturity dates between 2025/7 and 2025/12, 36 assets (499.1% of total balance) that have maturity dates between 2026/1 and 2026/6 and 1 assets (6.8% of total balance) that have maturity dates between 2036/1 and 2036/6.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
