Transaction Summary

The transaction closed on Jul 13 2017 and matures in Apr 2028. The pool's current aggregate principal balance is \$1133.0 million compared to \$1155.4 million at close.

The largest loan of the pool (10.1%) is secured by General Motors Building located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The second largest loan of the pool (5.3%) is secured by Del Amo Fashion Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 85%. The major tenants included J.C. Penney (9.23%) and Nordstrom (7.80%). The third largest loan of the pool (4.9%) is secured by 245 Park Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Societe Generale (32.62%) and JPMorgan Chase Bank, N.A. (13.08%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.35% and 40 months as of 10/15/2020, respectively. There are a total of 76 loans and 210 properties in the portfolio. The appraisal LTV was approximately 54.1% compared to the Original loan to value (LTV), which was approximately 55.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.30x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)











Most recent net operating income debt yield ranged from 6% to 25% with a weighted average NOI debt yield of 12.0%. NOI debt yield ranged from 6% to 25%. There were 6 assets (8% of total balance) with NOI debt yield between 6% and 8%, 17 assets (22% of total balance) with NOI debt yield between 8% and 10%, 19 assets (30% of total balance) with NOI debt yield between 10% and 12%, 15 assets (24% of total balance) with NOI debt yield between 12% and 14%, 12 assets (9% of total balance) with NOI debt yield between 14% and 16%, 3 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%, 2 assets (5% of total balance) with NOI debt yield between 22% and 24%, 1 assets (0% of total balance) with NOI debt yield between 24% and 26%

There were 1 assets (0.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 22 assets (16.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 29 assets (26.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (27.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (12.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (10.3% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (5.3% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (5.3% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 2.3x.







DSCRs ranged from 1.0x to 4.5x.There are 15 assets (10.6% of total balance) with DSCR between 1.0x and 1.5x, 31 assets (25.8% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (14.6% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (21.3% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (20.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (7.1% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
