Transaction Summary

The transaction closed on Aug 22 2017 and matures in Jan 2033. The pool's current aggregate principal balance is \$1117.9 million compared to \$1133.4 million at close.

The largest loan of the pool (6.3%) is secured by 225 & 233 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Facebook (39.43%) and BuzzFeed Inc. (28.73%). The second largest loan of the pool (5.8%) is secured by 211 Mount Airy Road located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was DAIICHI SANKYO II (100.00%). The third largest loan of the pool (5.2%) is secured by Lakeside Shopping Center located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Dillard's (25.65%) and Macy's (18.95%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.36% and 40 months as of 10/15/2020, respectively. There are a total of 64 loans and 149 properties in the portfolio. The appraisal LTV was approximately 58.3% compared to the Original loan to value (LTV), which was approximately 58.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.29x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 6% to 23% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 6% to 23%. There were 4 assets (7% of total balance) with NOI debt yield between 6% and 8%, 13 assets (26% of total balance) with NOI debt yield between 8% and 10%, 16 assets (29% of total balance) with NOI debt yield between 10% and 12%, 16 assets (26% of total balance) with NOI debt yield between 12% and 14%, 5 assets (4% of total balance) with NOI debt yield between 14% and 16%, 6 assets (5% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 20% and 22%, 3 assets (3% of total balance) with NOI debt yield between 22% and 24%

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 15 assets (12.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (22.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 18 assets (39.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (16.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (1.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (6.6% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (2.7% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 2.3x.







DSCRs ranged from 1.0x to 4.5x.There are 9 assets (5.2% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (27.8% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (21.5% of total balance) with DSCR between 2.0x and 2.5x, 13 assets (24.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (10.9% of total balance) with DSCR between 3.0x and 3.5x, 4 assets (7.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.7% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.5x.

There are 3 assets (7.2% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (0.4% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (1.2% of total balance) that have maturity dates between 2026/7 and 2026/12, 29 assets (41.8% of total balance) that have maturity dates between 2027/1 and 2027/6, 27 assets (37.6% of total balance) that have maturity dates between 2027/7 and 2027/12, 1 assets (1.8% of total balance) that have maturity dates between 2028/1 and 2028/6, 1 assets (4.0% of total balance) that have maturity dates between 2032/1 and 2032/6 and 1 assets (5.8% of total balance) that have maturity dates between 2033/1 and 2033/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
