Transaction Summary

The transaction closed on Aug 22 2017 and matures in Jan 2033. The pool's current aggregate principal balance is \$1116.1 million compared to \$1133.4 million at close.

The largest loan of the pool (6.3%) is secured by 225 & 233 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Facebook (39.43%) and BuzzFeed Inc. (28.73%). The second largest loan of the pool (5.8%) is secured by 211 Mount Airy Road located in metropolitan area. Occupancy at the subject was 100%. The third largest loan of the pool (5.2%) is secured by Lakeside Shopping Center located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Dillard's (25.65%) and Macy's (18.95%).

age (WALA) were 4.36% and 43 months as of 01/15/2021, respectively. There are a total of 64 loans and 149 properties in the portfolio. The appraisal LTV was approximately 58.2% compared to the Original loan to value (LTV), which was approximately 58.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.29x. As of 01/15/2021, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration





Occupancy Distribution (%)





Among assets in the portfolio, there are 11 properties (22% of total balance) located in New York, 5 properties (12% of total balance) in New Jersey, 7 properties (9% of total balance) in Illinois, 8 properties (7% of total balance) in Maryland, 16 properties (7% of total balance) in California, 4 properties (6% of total balance) in Louisiana and 27 properties (5% of total balance) in Texas. Other properties are located in the state of Washington DC, Georgia, Connecticut, Pennsylvania, Oklahoma, Tennessee, Alabama, Iowa, Wyoming, Nevada, Michigan, New Mexico, Washington, Oregon, Utah, Vermont, Florida, Arizona, Indiana, Idaho, Colorado, Virginia, Minnesota, Kentucky, Wisconsin, North Carolina and Arkansas.

Among all the assets in the portfolio, 2 assets (9% of total balance) had LTVs between 30% and 40%, 9 assets (20% of total balance) with LTVs between 40% and 50%, 13 assets (16% of total balance) with LTVs between 50% and 60%, 34 assets (44% of total balance) with LTVs between 60% and 70% and 6 assets (11% of total balance) with LTVs between 70% and 80%.








NCF DSCR



All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 15 assets (12.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (21.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 18 assets (39.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (16.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (1.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (6.6% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (2.7% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 2.3x.








DSCRs ranged from 1.0x to 4.5x. There are 9 assets (5.2% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (27.7% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (21.5% of total balance) with DSCR between 2.0x and 2.5x, 13 assets (24.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (10.9% of total balance) with DSCR between 3.0x and 3.5x, 4 assets (7.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.7% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
