## Transaction Summary

The transaction closed on Mar 14 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$603.0 million compared to \$616.8 million at close.

The largest loan of the pool (8.9%) is secured by Hyatt Place Portfolio located in Dallas-Plano-Irving, TX-17.27% metropolitan area. Occupancy at the subject was 72%. The second largest loan of the pool (8.5%) is secured by McLean Data Center Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 97%. The major tenants included Level 3 Communications (51.48%) and ZAYO GROUP LLC. (48.52%). The third largest loan of the pool (6.4%) is secured by International Paper Global HQ located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was International Paper (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.98% and 45 months as of 10/15/2020, respectively. There are a total of 58 loans and 75 properties in the portfolio. The appraisal LTV was approximately 60.3% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.91x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

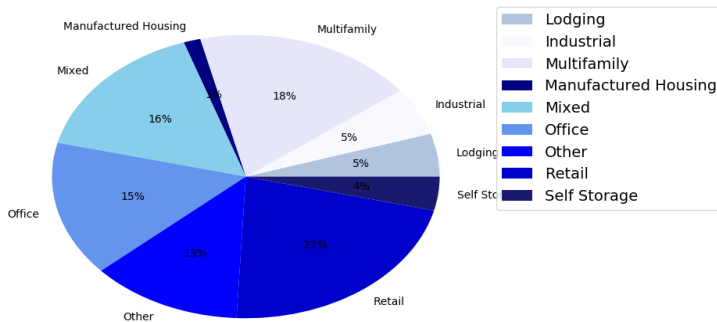

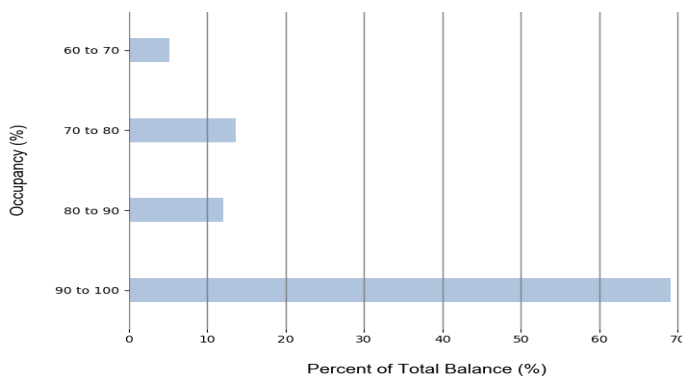

Occupancy Distribution (%)

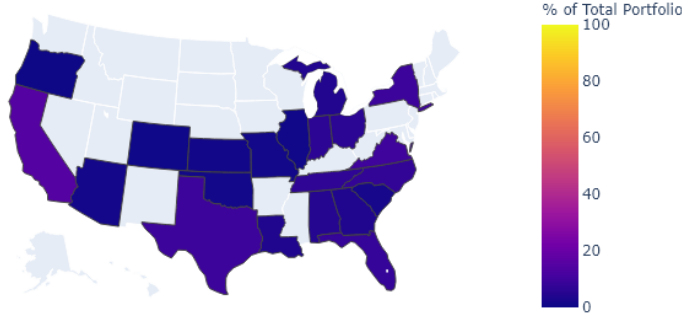

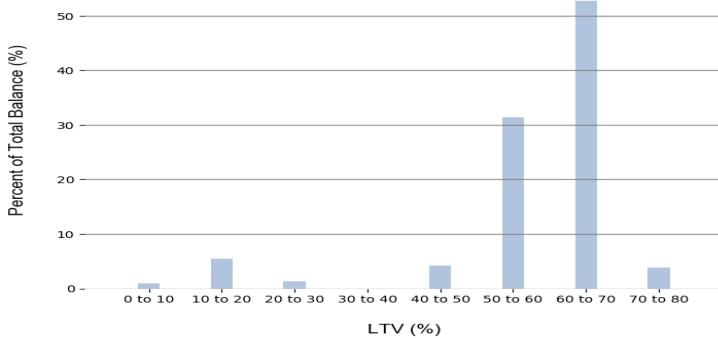
Local Distribution

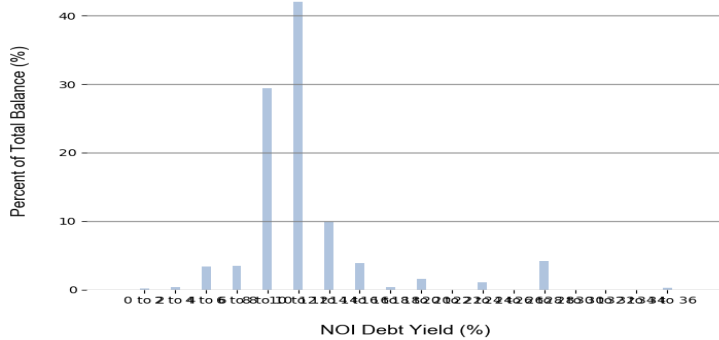

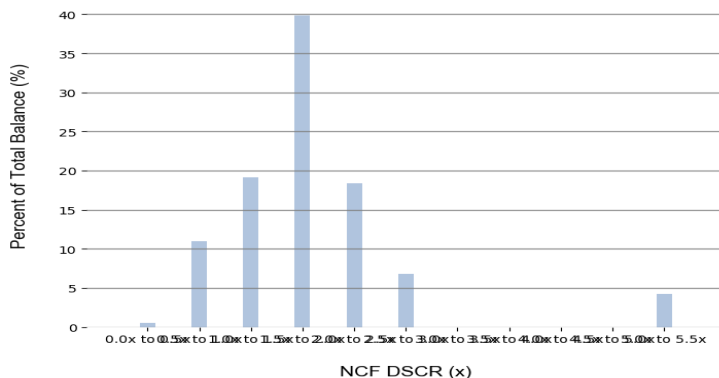
NOI Debt Yield (%)

**NCF DSCR**

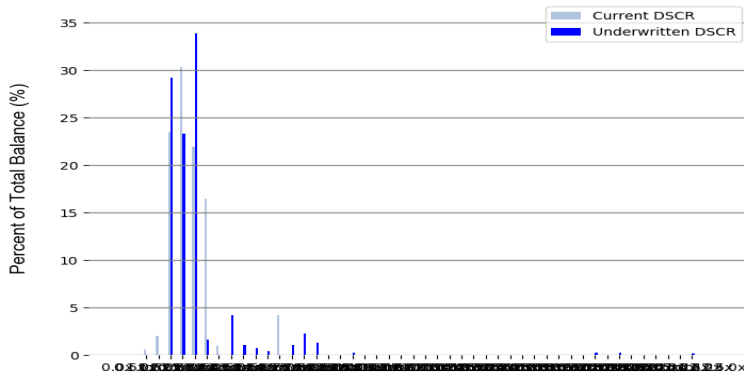
Net Cash Flow DSCR (x)

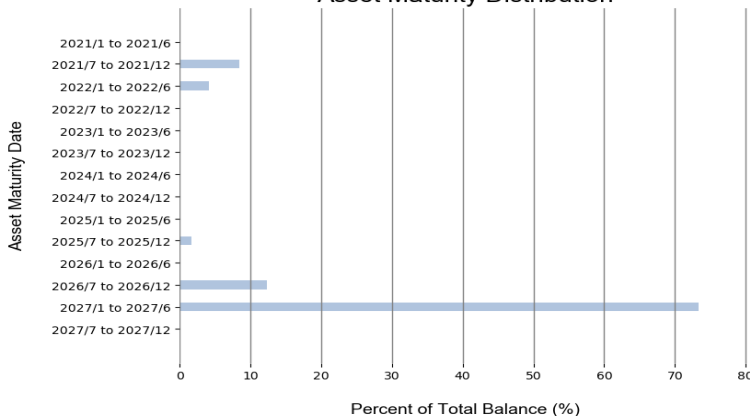
**DSCR Distribution (x)**



DSCRs ranged from 0.0x to 6.0x. There are 2 assets (0.6% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (2.0% of total balance) with DSCR between 0.5x and 1.0x, 17 assets (23.4% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (30.3% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (21.9% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (16.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.2% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (8.5% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (4.2% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (1.7% of total balance) that have maturity dates between 2025/7 and 2025/12, 8 assets (12.3% of total balance) that have maturity dates between 2026/7 and 2026/12 and 47 assets (73.3% of total balance) that have maturity dates between 2027/1 and 2027/6.

## Sensitivity Analysis

### Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

### 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
