Transaction Summary

The transaction closed on Mar 14 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$602.1 million compared to \$616.8 million at close.

The largest loan of the pool (8.9%) is secured by Hyatt Place Portfolio located in Dallas-Plano-Irving, TX-17.27% metropolitan area. Occupancy at the subject was 72%. The second largest loan of the pool (8.5%) is secured by McLean Data Center Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 97%. The major tenants included Level 3 Communications (51.48%) and ZAYO GROUP LLC. (48.52%). The third largest loan of the pool (6.4%) is secured by International Paper Global HQ located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was International Paper (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.98% and 47 months as of 12/15/2020, respectively. There are a total of 58 loans and 75 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.91x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.








Local Distribution





EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
