Transaction Summary

The transaction closed on Mar 14 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$510.6 million compared to \$532.0 million at close.

The largest loan of the pool (10.3%) is secured by Hyatt Place Portfolio located in Dallas-Plano-Irving, TX-17.27% metropolitan area. Occupancy at the subject was 72%. The second largest loan of the pool (7.5%) is secured by International Paper Global HQ located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was International Paper (100.00%). The third largest loan of the pool (6.5%) is secured by Preferred Freezer Vernon located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Preferred Freezer (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.03% and 62 months as of 03/15/2022, respectively. There are a total of 55 loans and 72 properties in the portfolio. The appraisal LTV was approximately 59.6% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.62x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 43% with a weighted average NOI debt yield of 10.3%. NOI debt yield ranged from 2% to 43%. There were 2 assets (2% of total balance) with NOI debt yield between 2% and 4%, 5 assets (5% of total balance) with NOI debt yield between 4% and 6%, 5 assets (2% of total balance) with NOI debt yield between 6% and 8%, 11 assets (30% of total balance) with NOI debt yield between 8% and 10%, 18 assets (36% of total balance) with NOI debt yield between 10% and 12%, 7 assets (16% of total balance) with NOI debt yield between 12% and 14%, 4 assets (5% of total balance) with NOI debt yield between 14% and 16%, 2 assets (3% of total balance) with NOI debt yield between 16% and 18% and 1 assets (0% of total balance) with NOI debt yield between 42% and 44%.

NCF DSCR ranged from 0.0x to 3.0x. There were 1 assets (1.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (17.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 21 assets (28.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 12 assets (28.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (22.9% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (1.4% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.6x.







DSCRs ranged from 0.5x to 3.0x.There are 9 assets (7.8% of total balance) with DSCR between 0.5x and 1.0x, 18 assets (32.7% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (23.1% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (21.4% of total balance) with DSCR between 2.0x and 2.5x and 4 assets (15.0% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.8x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
