Transaction Summary

The transaction closed on Mar 27 2018 and matures in Mar 2034. The pool's current aggregate principal balance is \$704.9 million compared to \$715.6 million at close.

The largest loan of the pool (7.7%) is secured by Moffett Towers II - Building 2 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Amazon.com (96.71%). The second largest loan of the pool (7.1%) is secured by Airport Business Center located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included American Pacific Printers College Inc. (1.64%) and JustFoodForDogs LLC (1.55%). The third largest loan of the pool (6.4%) is secured by The SoCal Portfolio located in Los Angeles-Long Beach-Glendale, CA-33.22% Anaheim-Santa Ana-Irvine, CA-16.36% metropolitan area. Occupancy at the subject was 88%. The major tenants included Candor-AGS Inc. (5.70%) and The Capital Group Companies (4.02%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.64% and 34 months as of 12/15/2020, respectively. There are a total of 62 loans and 130 properties in the portfolio. The appraisal LTV was approximately 60.1% compared to the Original loan to value (LTV), which was approximately 61.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





Occupancy Distribution (%)




Local Distribution





There were 6 assets (7% of total balance) with NOI debt yield between 6% and 8%, 15 assets (29% of total balance) with NOI debt yield between 8% and 10%, 19 assets (40% of total balance) with NOI debt yield between 10% and 12%, 13 assets (14% of total balance) with NOI debt yield between 12% and 14%, 6 assets (6% of total balance) with NOI debt yield between 14% and 16%, 2 assets (2% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%





DSCRs ranged from 0.0x to 4.5x.There are 1 assets (1.4% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.2% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (7.0% of total balance) with DSCR between 1.0x and 1.5x, 25 assets (30.9% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (38.9% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (5.2% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (12.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.1% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
