## **Transaction Summary**

The transaction closed on Mar 27 2018 and matures in Mar 2034. The pool's current aggregate principal balance is \$697.4 million compared to \$715.6 million at close.

The largest loan of the pool (7.7%) is secured by Moffett Towers II - Building 2 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Amazon.com (96.71%). The second largest loan of the pool (7.2%) is secured by Airport Business Center located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 94%. The major tenants included JustFoodForDogs LLC (1.55%) and Aids Services Foundation Inc. (1.01%). The third largest loan of the pool (6.5%) is secured by The SoCal Portfolio located in Los Angeles-Long Beach-Glendale, CA-33.22% Anaheim-Santa Ana-Irvine, CA-16.36% metropolitan area. Occupancy at the subject was 88%. The major tenants included Candor-AGS Inc. (5.70%) and The Capital Group Companies (4.02%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.64% and 49 months as of 03/15/2022, respectively. There are a total of 62 loans and 130 properties in the portfolio. The appraisal LTV was approximately 59.7% compared to the Original loan to value (LTV), which was approximately 60.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.10x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





#### Occupancy Distribution (%)









Most recent net operating income debt yield ranged from 0% to 21% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 0% to 21%. There were 2 assets (1.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (0.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 21 assets (23.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 16 assets (23.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (29.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (2.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 4 assets (12.0% of total balance) with NCF DSCR between 3.0x and 3.5x and 3 assets (7.0% of total balance) with NCF DSCR between 3.5x and 4.0x. 



## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
