Transaction Summary

The transaction closed on May 17 2018 and matures in May 2033. The pool's current aggregate principal balance is \$758.8 million compared to \$767.3 million at close.

The largest loan of the pool (8.7%) is secured by Village at Leesburg located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 93%. The major tenants included Wegman's (26.13%) and Cobb Theaters (11.66%). The second largest loan of the pool (6.6%) is secured by 3495 Deer Creek Road located in metropolitan area. Occupancy at the subject was 100%. The major tenants included VMware INC. (100.00%) and Sprint (0.33%). The third largest loan of the pool (6.2%) is secured by Airport Business Center located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included American Pacific Printers College Inc. (1.64%) and JustFoodForDogs LLC (1.55%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.86% and 30 months as of 10/15/2020, respectively. There are a total of 44 loans and 55 properties in the portfolio. The appraisal LTV was approximately 62.5% compared to the Original loan to value (LTV), which was approximately 62.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.74x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.








Local Distribution





There were 4 assets (6.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (25.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (40.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (23.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.7% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.7x.







The most recent weighted average DSCR is 1.9x

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
